DECISION

150 CANAL STREET INC D/B/A HURRICANE'S AT THE GARDEN 150 CANAL STREET BOSTON, MA 02114

LICENSE#: 03673-RS-0116

VIOLATION DATE: 12/10/2022

HEARD: 4/25/2023

150 Canal Street Inc d/b/a Hurricane's at the Garden (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, April 25, 2023, regarding an alleged violation of M.G.L. c. 138, § 69 – Sale or delivery of an alcoholic beverage to an intoxicated person (1 Count). Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Quinn's report.

The following documents are in evidence:

- 1. Investigator Quinn's Report, 12/10/2022;
- 2. ABCC Application Summary Review, Transfer of License Approved, 10/17/2017;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Saturday, December 10, 2022, Investigators Cutter and David inspected the licensed premises of 150 Canal Street Inc d/b/a Hurricane's at the Garden ("Licensee") to determine the way its business was being conducted.
- 2. At approximately 3:30 p.m., Investigators Cutter and David entered the licensed premises, and their attention was drawn to an unknow male individual ("UM") in a Santa suit, who appeared to be intoxicated. UM was observed hugging people and spilling the two drinks, Vodka and Red Bull, in his possession.
- 3. At approximately 3:35 p.m., Investigators observed UM had an unsteady gait and a blank stare as he approached numerous people, physically touching, hugging and high fiving them.
- 4. At approximately 3:45 p.m., Investigators observed UM approach female patrons and dance erratically with them while spilling the drinks in his possession.

- 5. At approximately 3:55 p.m., Investigators observed UM quickly consumed the remainder of his drink. He approached the bar with an unsteady gait. His speech was slurred, and he fumbled as he grabbed straws from the bar and handed them to other patrons. UM was in a clear line of sight of the bartenders.
- 6. Based on their training and experience, Investigators determined UM was intoxicated.
- 7. Investigators observed UM order three Red Bull and vodkas from the bartender. The bartender delivered the three alcoholic beverages to UM. The bartender asked if he was "going to pay for those drinks." UM made payment with a credit card.
- 8. Investigators then observed UM ask the bartender how to carry the three drinks at once. The bartender showed UM how to carry the drinks. UM clumsily walked away from the bar with the three drinks, spilling them slightly.
- 9. Investigators Cutter and David then informed Investigators Keefe and Quinn of the violation.
- 10. Investigators Quinn and Keefe entered the licensed premises and identified UM to the manager on duty, Nolan.
- 11. Investigators Quinn and Keefe advised the manager of the violation and that a report would be filed with the Chief Investigator for further review.
- 12. The Licensee has held a license under M.G.L. c. 138, § 12 since 2017 with no previous violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated M.G.L. c. 138, § 69 – Sale or delivery of an alcoholic beverage to an intoxicated person (1 Count). Therefore, the Commission issues a **WARNING**.
