FOR THE PAST TWO YEARS, THERE HAS BEEN A SLOW BUT STEADY INTEREST GROWING ACROSS THE COMMONWEALTH TO ENTERTAIN A DISCUSSION AROUND THE FEASIBILITY OF HOSTING THE OLYMPIC AND PARALYMPIC GAMES IN 2024. THE MODERN OLYMPIC GAMES WERE FIRST HELD IN 1896 IN ATHENS, GREECE. SINCE 1988, THE PARALYMPIC GAMES HAVE BEEN HELD DIRECTLY AFTER THE OLYMPIC GAMES, IN THE SAME CITY, AND OFTENTIMES USING THE SAME VENUES. THE 2012 OLYMPICS IN LONDON SAW 10,500 ATHLETES FROM 88 COUNTRIES COMPETE IN 302 EVENTS IN 26 SPORTS ACROSS 34 VENUES. FOLLOWING THE LONDON OLYMPICS, THE PARALYMPIC GAMES COMPETITION SPANNED A TEN-DAY PERIOD, FEATURING OVER 4,200 ATHLETES FROM 164 COUNTRIES COMPETING IN 503 EVENTS IN 20 SPORTS. THE NUMBER OF ATHLETES AND NATIONS PARTICIPATING IN THE PARALYMPIC GAMES HAS STEADILY INCREASED OVER THE PAST 20 YEARS,
