DECISION

BOSWORTH PLACE INC. D/B/A BEANTOWN PUB 100 TREMONT ST. BOSTON, MA 02108 LICENSE#: 01535-RS-0116

VIOLATION DATE: 10/25/2019

HEARD: 2/11/2020

Bosworth Place Inc. d/b/a Beantown Pub (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, February 11, 2020, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: M.G.L. Ch. 138, § 34C Possession of an alcoholic beverage by a person under twenty-one years of age (1 count). Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Temple's Report.

FINDINGS OF FACT

- On Friday, October 25, 2019, at approximately 7:15 p.m., Investigators Velez and Temple
 ("Investigators") conducted an investigation of the business operation of Bosworth Place
 Inc. d/b/a Beantown Pub to determine the manner in which its business was being
 conducted.
- 2. Investigators observed a youthful appearing individual, in possession of alcoholic beverages, seated near the back bar next to the pool tables. Investigators identified themselves and asked to see proof of legal age.
- 3. Underage #1, actual date of birth 10/17/2002 (age 18), was in possession of a vodka cranberry mixed drink. He stated to Investigators that he had not provided any identification when he entered the establishment.

- 4. Investigators identified the underage patron to the doorman. Investigators then informed the Manager, Roger Zeghibe of the violation and that a report would be filed with the Chief Investigator for further action.
- 5. Mr. Zeghibe is the Licensee and Manager. He appeared at the Commission hearing and testified that minors are allowed on the premise but only when accompanied by an adult and for the purpose of ordering food. Mr. Zeghibe testified that he reviewed the surveillance tape from the night of the incident, and observed the older male patron who was with the minor patron purchase the alcoholic beverage and then give it to the minor patron. Investigator Temple confirmed that was the case.
- 6. The Licensee has held a license under M.G.L. c. 138, § 12 since 1998 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated of 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: M.G.L. Ch. 138, § 34C Possession of an alcoholic beverage by a person under twenty-one years of age (1 count). The Commission issues a WARNING.
