- This project addresses the structurally deficient bridge that carries the Bowker Overpass over I-90. This project also reconfigures the ramp system to better manage traffic patterns and to reconnect the Emerald Necklace.
- Project Investment meets Beyond Mobility priorities for Safety, Reliability, and Resiliency.

Scope of Services

- Addresses immediate needs to replace the deteriorated Bridge infrastructure, improve deficient pedestrian and bicycle accommodations enhance safety, and reduce ongoing maintenance costs.
- B-16-052 was originally constructed in 1965 and consists of four simple span rolled beams with a composite concrete deck. The piers are reinforced concrete column and wall piers on concrete filled pipe piles. The overall condition of the bridge is poor.



 The roadway work is comprised of full-depth roadway reconstruction, demolition and construction of medians as required at intersections, installation of granite curb, pavement markings, installation of new roadway drainage, construction of underground utilities, installation of traffic signals, extensive landscaping, a new shared-use path for non-motorized traffic, and related work.



Construction Management Approach

- Lane closures will have impacts to the overall traffic pattern. Demolition and beam installation work to be completed during offpeak traffic hours with rolling road blocks on I-90. Traffic Staging shall be done in Four Stages (Stage 1-4).
- During Stage 1, I-90 will be reduced to three (3) westbound lanes and three (3) eastbound lanes.
- When required, traffic detours during offpeak traffic times may be implemented during bridge construction for safety and truck movement.
- Construction will take approximately (1,712 days) four (4) years and nine (9) months to complete.





Questions from Capital Programs Committee

Q1.What is the condition of the existing bridge structure?

• A1. The existing bridge condition is poor and structurally deficient

Q2. Can MassDOT provide the crash safety data generated for the project?

 A2. Yes. The Commonwealth Avenue intersections with Charlesgate East and West are identified as a Highway Safety Improvement Program (HSIP) high crash cluster from 2015-2017 and 2018-2020. While outside the project area, the intersection of Beacon Street at Charlesgate East is also identified as a high crash cluster. Full safety analysis has been provided in your Board materials.

Safety Analysis

A safety analysis in the study area was performed to identify and evaluate possible safety issues that exist at the major study area intersections. The data was collected for both the Storrow Drive and Bowker Overpass projects. Crash data was obtained from the MassDOT IMPACT crash portal, Boston Vision Zero portal, and local police crash reports provided by the MassDOT Traffic and Safety Engineering Section and by the Boston Police Department covering the years of 2015 through 2018. Additional data was collected from the MassDOT IMPACT crash portal and from the Boston Police Department for 2019-2020. Based on the reported crashes, the following conclusions can be made for the study area intersections, Storrow Drive, and the Bowker Overpass.

The Commonwealth Avenue intersections with Charlesgate East and West are identified as a Highway Safety Improvement Program (HSIP) high crash cluster from 2015-2017 and 2018-2020. An RSA was held for these locations on June 8, 2021 to identify the existing safety concerns and identify short-, mid-, and long-term solutions. A summary of the RSA is provided in the following sections.

While outside the project area, the intersection of Beacon Street at Charlesgate East is also identified as a high crash cluster. An RSA was performed on September 30, 2021. Safety improvements to this area are included in the PFN 606728. The links to both RSAs are located in **Appendix D**.

Table 9 provides a summary of the reported crashes for the intersections and segments within theproject area. The collision diagrams and crash rate worksheets can be found in **Appendix E**.

SIGNALIZED INTERSECTIONS

COMMONWEALTH AVENUE SOUTH AT CHARLESGATE EAST

The crashes reported include seven angle crashes and eight sideswipe crashes, making up most of the total crashes reported within the six-year study period. The crash rate of the intersection is 0.31 crashes per million entering vehicles compared to the District 6 average of 0.71 crashes per million entering vehicles. Two crashes involved a cyclist or pedestrian.



COMMONWEALTH AVENUE SOUTH AT CHARLESGATE WEST

The crashes reported at the intersection of Commonwealth Avenue South at Charlesgate West include 35 angle crashes, the main manner of collision at this location. The crash rate of 0.62 crashes per million entering vehicles for the intersection is below the District 6 average of 0.71 crashes per million entering vehicles. Of the 45 total crashes, 24 crashes reported a driver going through a red signal.

BOYLSTON STREET AT BOWKER OVERPASS

The intersection of Boylston Street at Bowker Overpass crash reports showed six sideswipes, four rear-end crashes, and three single-vehicle collisions. The crash rate of 0.10 crashes per million entering vehicles for the intersection is below the District 6 average of 0.71 crashes per million entering vehicles. Based on the crash reports, the sideswipes were attributed to drivers attempting to change lanes and the rear-end collisions were attributed to vehicles stopping at the signal. One of the crashes involved a pedestrian.

SEGMENTS

The crashes reported for the Bowker Overpass showed that 34 rear-end, 16 sideswipe crashes, and eight single-vehicle crashes were reported. The crash rate for the segment of 2.63 crashes per million entering vehicles is below the District 6 crash rate of 3.58 crashes per million entering vehicles. Of the 34 rear-end crashes, a majority were related to slowing or stopped traffic traveling northbound and southbound on the Bowker Overpass. Two rear-end crashes were also related to vehicles slowing from the Storrow Drive eastbound off-ramp onto Bowker Viaduct. Of the Bowker Overpass sideswipes, six were noted to be related to construction closures on the northbound side of the Bowker Overpass requiring vehicles to merge into one lane. A few were also due to failure to yield. Additionally, a couple crashes were related to vehicles merging traveling northbound on the Bowker Overpass.

ROAD SAFETY AUDIT (RSA)

During the RSA, several safety concerns were noted in detail and are briefly summarized below:

COMMONWEALTH AVENUE AT CHARLESGATE EAST AND CHARLESGATE WEST

- Insufficient pedestrian and bicycle accommodations;
- Intersection visibility; and
- Traffic Operations.



Safety Enhancements

This section summarizes the safety enhancements at the three intersections being fully or partially reconstructed by the project.

BOYLSTON STREET AT BOWKER OVERPASS

- Crosswalks have been proposed at all legs of the approaches at Boylston Street at Bowker Overpass intersection to improve pedestrian and bicycle safety and connectivity.
- All traffic signal equipment will be upgraded, and video detection will be provided. New
 mast arms are proposed to provide overhead signal heads with backplates and
 retroreflective borders to improve signal visibility.
 - Arrow signal indications are proposed for exclusive turning or thru movements where appropriate.
- Traffic signal clearance intervals including pedestrian crossing times will be updated to comply with the latest guidance and revised intersection geometry.
- Skip lines have been added through intersections where appropriate to delineate travel paths.

COMMONWEALTH AVENUE SOUTH AT CHARLESGATE EAST

With the reconfiguration of the ramps to and from Commonwealth Avenue, an opportunity arose to improve the two intersections at Commonwealth Avenue South. The RSA conducted at these two intersections gave insight on the issues and possible improvements that could be made to provide safety enhancements at the intersections.

- A new crosswalk with ADA-compliant ramps is proposed to be added on the eastbound leg of Commonwealth Avenue South, where a previous pedestrian crash resulting in an injury occurred, as well as a new crosswalk with ADA-compliant ramps across the northern leg of Commonwealth Avenue South at Charlesgate East, improving connectivity along desire lines as recommended in the RSA.
 - All existing crosswalks will be remarked and constructed with ADA/AAB compliant curb ramps as recommended in the RSA.
- The ramp removal at the Commonwealth Avenue at Charlesgate East allows for more park and sidewalk space on the south side of the intersection and reduces the length of the crosswalk across Charlesgate East.
 - Consolidation of the crosswalks across this ramp were listed as a recommended countermeasure under the RSA.



- A two-stage, left-turn box has been added to the intersection along with conflict markings, providing clarity for both cyclists and vehicles as to the path of travel for cyclists.
 - Formalizing the bicycle maneuver across travel lanes to provide a continuous and clearer path for bicycle as recommended in the RSA.
- New mast arms are proposed to provide overhead signals, backplates, and retroreflective borders for increased signal visibility as recommended by the RSA.
 - Arrow signal indications are proposed for exclusive turning or thru movements where appropriate.
- Traffic signal clearance intervals including pedestrian crossing times will be updated to comply with the latest guidance and revised intersection geometry.
- Skip lines have been added through intersections where appropriate to delineate travel paths.

COMMONWEALTH AVENUE SOUTH AT CHARLESGATE WEST

- New crosswalks with ADA-compliant ramps are proposed across the north and east legs of the intersection.
 - All existing crosswalks will be remarked and constructed with ADA/AAB compliant curb ramps as recommended in the RSA.
- New lane-usage markings and signage are proposed to provide additional guidance as recommended by the RSA.
- New mast arms are proposed to provide overhead signals, backplates, and retroreflective borders for increased signal visibility as recommended by the RSA.
 - Arrow signal indications are proposed for exclusive turning or thru movements where appropriate.
- Traffic signal clearance intervals including pedestrian crossing times will be updated to comply with the latest guidance and revised intersection geometry.
- Skip lines have been added through intersections where appropriate to delineate travel paths.

Build Condition Traffic Volumes

Traffic volumes for the Bowker Overpass improvements do not differ significantly from the No-build Conditions. With the removal of the Commonwealth Avenue Off-ramp (B-16-365 (4FD)), vehicles

PURPOSE:

The purpose of this Staff Summary is to request that the Board of Directors authorize and approve the Secretary/CEO, or her designee, to execute MassDOT Contract No. 127762-606496 Boston- Bridge Superstructure Replacement and Widening, B-16-052, Bowker Overpass Over I-90, MBTA and Ipswich Street, for Highway Construction, with Barletta Heavy Division, Inc., for the amount of <u>\$83,000,000.25</u> for a total duration, not to exceed, 1712 days (4 years and 9 months) from Notice to Proceed (NTP).

DISCUSSION: This Project includes a Bridge Superstructure Replacement with Widening and Related Work The award of Contract No. 127762-606496 Boston- Bridge Superstructure Replacement and Widening, B-16-052, Bowker Overpass Over I-90, MBTA and Ipswich Street, will address immediate needs to replace the deteriorated Bridge infrastructure and pavement, improve deficient pedestrian and bicycle accommodations while enhancing safety, and reduce ongoing maintenance costs with the demolition and removal of the ramp over the Muddy River.

B-16-052 was originally constructed in 1965 and consists of four simple span rolled beams with a composite concrete deck. The piers are reinforced concrete column and wall piers on concrete filled pipe piles. The abutment is supported on concrete filled pipe piles and supports a concrete tee beam approach structure. The overall condition of the bridge is poor.

The roadway work is comprised of excavation, borrow, grading, installation of full depth hot mix asphalt pavement, pavement milling and overlay, demolition and construction of medians as required at intersections, installation of granite curb, pavement markings, installation of new roadway drainage, construction of underground utilities, installation of traffic signals, extensive landscaping, a new shared-use path for non-motorized traffic, and related work.

PROCUREMENT:

On August 17, 2024, the Highway Division advertised this contract for bids. On January 28, 2025, the Highway Division opened bids for this contract and two (2) bids were received. Barletta Heavy Division Inc. was the lowest responsible and eligible bidder with a bid price of **\$83,900,000.25**.

The bids were reviewed by engineers in the Construction, Construction Contracts and Project Management Sections. The Highway Division has accepted the bid submitted by Barletta Heavy Division Inc., which at <u>\$83,900,000.25</u> is 12.48% higher than the office estimate of <u>\$74,591,693.73</u>.

The following is the list of bidders with the corresponding bid prices:

Disadvantaged Business Enterprise ("DBE") participation is required. The DBE requirement for this Project is 12.05%. MassDOT's Office for Diversity and Civil Rights has reviewed the DBE information included in the Proposal of the chosen bidder and recommends award of the DBB Contract to this team.

FINANCIAL IMPACT/BUDGET SOURCE:

This action is funded through Federal Aid – Next Generation Bridge (GANs) Funding, which is 80% Federal Aid-and (NFA) – Next Generation Bridge GANs. All funding necessary for the construction of the project is provided in the FY2025– FY2029 MassDOT Capital Investment Plan. There will be no potential projects placed at risk with the approval of this request by the MassDOT Board of Directors.
