## DECISION

Kitty O'Shea's, Inc. dba Flann O'Brien's (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, November 26, 2013, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: c. 138, §34C Possession of an alcoholic beverage by a person under 21 years of age (1 count). Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Temple's Report.

## FACTS

- 1. On Friday, September 6, 2013, at approximately 8:40 p.m., Investigators Kenny, Guarino-Wilichoski, and Temple conducted an investigation of the business operation of Kitty O'Shea's, Inc. dba Flann O'Brien's to determine the manner in which its business was being conducted.
- 2. Investigators observed six youthful looking individuals seated to the right of the entrance, facing the bar.
- 3. Investigators approached the male individuals who were in possession of alcoholic beverages.
- 4. Investigators asked all the individuals for proof of age.

- 5. One male individual, Christopher Domsodi, provided investigators with a fraudulent identification. Mr. Domsodi's actual date of birth is a fraudulent (age 19).
- 6. Investigator Wilichoski observed Mr. Domsodi in actual possession of a Blue Moon bottle of beer.
- 7. Mr. Domsodi stated that he provided a fraudulent identification when he entered the licensed premises. That identification gave his date of birth (age 23).
- Investigators asked to speak to the manager on duty but were told that there was no manager on duty.
- 9. Investigators identified the underage patron to the waitress, Maria Fullerton, and informed her of the violation and that a report would be submitted to the Chief Investigator for review.

## **CONCLUSION**

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: c. 138, §34C Possession of an alcoholic beverage by a person under 21 years of age (1 count). As the licensee has had no violations in more than ten (10) years, the Commission issues a WARNING.
