After a hearing on March 3, 2015, the Commission finds Glory RBG LLC dba Julep Bar / Blue violated 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, To Wit: c. 138, §34C - Possession of an Alcoholic Beverage by a Person Under Twenty-One (21) Years of Age (9 Counts).

The Commission suspends the licensee's license for a total of fifteen (15) days to be served. The suspension shall commence on Wednesday, May 13, 2015 and terminate on Wednesday May 27, 2015. The license will be delivered to the Local Licensing Board or its designee on Wednesday, May 13, 2015 at 9:00 A.M. It will be returned to the licensee Thursday, May 28, 2015.

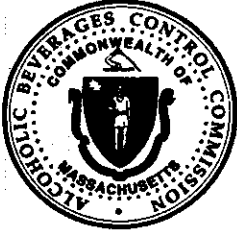
You are advised that pursuant to the provisions of M.G.L. c.138 §23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. DECISION

GLORY RBG LLC DBA JULEP BAR / BLUE
200 HIGH STREET
BOSTON, MA 02110

Glory RBG LLC dba Julep Bar / Blue (the "Licensee") holds an alcohol beverage license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, March 3, 2015, regarding the alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, To Wit: c. 138, §34C - Possession of an Alcoholic Beverage by a Person Under Twenty-One (21) Years of Age (9 Counts). Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Temple's Report.

The following documents are in evidence:

1. Investigator Temple's Investigative Report dated December 5, 2014; and
 2. Licensee's Stipulation of Facts;
- A. Licensee's Video of the Interior of the Bar (showing bouncer checking patrons' identification)

There is one (1) audio recording of this hearing.

FACTS

1. On Friday, December 5, 2014, at approximately 4:45 p.m., Investigators Guarino, Kenny, Velez and Temple, along with Chief Investigator Mahony investigated the business operation of Glory RBG LLC dba Julep Bar / Blue to determine the manner in which its business was being conducted.
2. While conducting an inspection of the bar area, investigators observed several youthful looking individuals. Investigators observed nine (9) underage individuals in possession of alcoholic beverages.
3. Investigators observed Nicole A [REDACTED], actual date of birth 04/20/1995 (age 19) in possession of a vodka and soda. Ms. Arroza stated that she did not present identification when she entered the bar.
4. Investigators observed Carolina A [REDACTED], actual date of birth 02/08/1995 (age 19) in possession of a vodka and Sprite® soda. Ms. Amaral presented investigators with a fraudulent Colombia identification in the name of Carolina M [REDACTED], date of birth [REDACTED] (age 22).


5. Investigators observed Sophia F [REDACTED], actual date of birth 05/15/1995 (age 19) in possession of a vodka and cranberry juice. Ms. F [REDACTED] presented investigators with a fraudulent El Salvador identification in her name and a date of birth [REDACTED] (age 22).
6. Investigators observed Isabelle G [REDACTED], actual date of birth 03/28/1994 (age 20) in possession of a vodka and soda. Ms. G [REDACTED] stated that she did not present identification when she entered the bar.
7. Investigators observed Constanza L [REDACTED], actual date of birth 12/07/1995 (age 18) in possession of a raspberry vodka. Ms. L [REDACTED] stated that she did not present identification when she entered the bar.
8. Investigators observed Veronica G [REDACTED], actual date of birth 09/08/1995 (age 19) in possession of a vodka and cranberry juice. Ms. G [REDACTED] presented investigators with an Arizona identification in the name of Patricia Z [REDACTED], date of birth [REDACTED] (age 23).
9. Investigators observed Camila F [REDACTED], actual date of birth 09/13/1994 (age 20) in possession of a vodka and Red Bull energy drink. Ms. F [REDACTED] stated that she did not present identification when she entered the bar. Ms. F [REDACTED] presented investigators with a Dominican Republic Driver's License in the name of Cristina F [REDACTED].
10. Investigators observed Mariana M [REDACTED], actual date of birth 11/21/1994 (age 20) in possession of a vodka and cranberry juice. Ms. M [REDACTED] presented investigators with a passport from Mexico in the name of Susana A [REDACTED], which she stated that she presented as identification when she entered the bar.
11. Ms. M [REDACTED] was accompanied by another underage female, Lucia B [REDACTED], actual date of birth 08/22/1996 (age 18).
12. It should be noted that after the presence of investigators was made known, the bar crowd diminished significantly.
13. Each underage patron was identified to the manager on duty, Zach Barnett.
14. Investigators advised Mr. Barnett of the violation and that a report would be submitted to the Chief Investigator for review.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, To Wit: c. 138, §34C - Possession of an Alcoholic Beverage by a Person Under Twenty-One (21) Years of Age (9 Counts). Therefore, the Commission **suspends the license for thirty-five (35) days of which fifteen (15) days will be served and twenty (20) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**


