## DECISION

HOST INTERNATIONAL INC. D/B/A BONFIRE LOGAN AIRPORT TERMINAL B BOSTON, MA 02201 LICENSE#: 0116-02017

VIOLATION DATE: 08/08/2017

HEARING DATE: 2/13/2018

Host International Inc. d/b/a Bonfire (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, February 13, 2018, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Di Cicco's Report.

The following documents are in evidence:

- 1. Investigator Di Cicco's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.
- A. TIPS Certificate for P. Charles; and
- B. Licensee's Sale & Service Policy for Adult Beverages.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

## **FACTS**

- 1. On Tuesday, August 8, 2017, at approximately 5:49 p.m., Investigators Wilichoski and Di Cicco ("Investigators") investigated the business Host International Inc. d/b/a Bonfire.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a Coors Light beer, for seven dollars and thirty-five cents (\$7.35). The underage operative was not asked for identification.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business more than 10 years with no prior violation, the Commission issues a **WARNING**.
