## **DECISION**

J. PACE & SON UPTOWN INC. D/B/A J. PACE & SON WATERFRONT

1 PARK LANE BOSTON, MA 02201 LICENSE#: 0116-01908

**VIOLATION DATE: 08/01/2017 HEARING DATE: 11/14/2017** 

J. Pace & Son Uptown Inc. d/b/a J. Pace & Son Waterfront (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, November 14, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Guarino-Wilichoski's Report.

The following documents are in evidence:

- 1. Investigator Guarino-Wilichoski's Compliance Check Field Report;
- 2. Licensee's Stipulation of Facts; and
- 3. 6-Pack of Bud Light beer.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

## **FACTS**

- 1. On Tuesday, August 1, 2017, at approximately 5:46 p.m., Investigator Wilichoski and State Trooper Christopher Fraser ("Investigators") investigated the business operation of J. Pace & Son Uptown Inc. d/b/a J. Pace & Son Waterfront.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 6-pack of Bud Light beer, for seven dollars and ninety-nine cents (\$7.99). The underage operative was not asked for identification.

## **CONCLUSION**

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for three (3) days which will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
