**MAHARAJ AND SWAMI, LLC
D/B/A QUICK PICK CONVENIENCE

Maharaj and Swami, LLC d/b/a Quick Pick Convenience (“Licensee”) holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (“ABCC” or “Commission”) held a hearing on Tuesday, October 22, 2024, regarding an alleged violation of M.G.L. Ch. 138 § 34 – Sale or Delivery of alcoholic beverages to a person under twenty-one (21) years of age (1 Count). Prior to the commencement of the hearing, the Licensee stipulated to the facts in Investigator Teehan’s Report.

FINDINGS OF FACT

1. On Friday, September 6, 2024, Investigators Cutter and Teehan (“Investigators”) inspected the business operation of Maharaj and Swami, LLC d/b/a Quick Pick Convenience (“Licensee” or “Quick Pick”).


2. At approximately 9:20 p.m., while outside the licensed premises, Investigators observed a youthful appearing male individual exit the licensed premises in possession of a black bag which appeared to contain an alcoholic beverage.
3. Investigators approached the individual, identified themselves and requested proof of legal age to possess alcoholic beverages. It was confirmed the bag contained a bottle of Barefoot Pinot Grigio.
4. Underage #1, actual date of birth 12/30/2004 (age 20), stated to Investigators he was not 21 years old and he used a fraudulent Michigan Driver's License to purchase the alcoholic beverages.
5. Investigators informed the clerk, Nimesh Rana, of the violation and that a report would be submitted to the Chief Investigator for further review.
6. Mr. Rana, Licensee and Manager, appeared at the Commission along with Nitin Patel, Licensee. Mr. Rana testified Underage #1 presented an identification which scanned as legitimate. (Exhibit C) Mr. Rana further testified to the Licensee's policy of requesting and checking identification.
7. The Licensee holds a license under M.G.L. c. 138, § 15 with no prior violations.

CONCLUSION


Based on the evidence, the Commission finds the Licensee violated Ch. 138 § 34 – sale or delivery of alcoholic beverages to a person under twenty-one (21) years of age (1 Counts). As a result, the Commission **issues a WARNING.**


