Our Symphony 8 Inc. dba Symphony 8/Siansa (the "Licensee") holds an all alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, January 24, 2012, regarding an alleged violation of M.G.L. c. 138 §34 (3 counts). Prior to the commencement of the hearing, the licensee stipulated to the violations alleged in Investigator Mark Kenny's Report.

FACTS

- 1. On Friday, September 30, 2011, at approximately 12:45: a. m., Chief Investigator Mahony, along with Investigators Kenny and Teehan, investigated the business operation of Our Symphony 8 Inc. dba Symphony 8/Siansa.
- 2. Investigators entered the premises and observed youthful looking individuals in possession of alcoholic beverages.
- 3. Investigators identified themselves and asked the individuals for identification.
- 4. The information recorded indicated the individuals were under twenty-one (21) years of age.
- 5. The female individual, date of birth May 6, 1992, age nineteen (19), was in possession of a fake California Driver's License.
- 6. The first male individual, date of birth June 19, 1991, age twenty (20), was in possession of a fake New York Driver's License.
- 7. The second male individual, date of birth February 19, 1991, age twenty (20), was in possession of a fake New Jersey Driver's License.

- 8. Each underage individual was in possession of a draft beer.
- 9. Investigators spoke with the manager on duty, Ashley Forsyth, and informed her that a report would be filed with the Chief Investigator for review.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated M.G.L. c. 138 §34 (3 counts). Therefore, the Commission suspends the license for ten (10) days which will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
