MEMORANDUM AND ORDER ON LICENSEE'S REOUEST FOR RECONSIDERATION

PITCHER'S MOUND, LLC DBA DIAMOND AT FENWAY 72 BROOKLINE AVENUE BOSTON, MA 02215

Pitcher's Mound, LLC dba Diamond at Fenway (the "Licensee") holds an all alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, January 14, 2014, regarding the Licensee's Motion to Reconsider Amending Certain Conditions placed on its license.

On the Harry M. Stevens license application dated April 6, 2011, the Commission approved the license with conditions. Specifically that:

- 1) Alcohol sales are not to begin until 2 hours prior to the start of a game;
- 2) The License is only to be used for Major League Baseball games;
- 3) All additional staffing and security personnel and measures stipulated to in the letter dated August 22, 2002, to this Commission from General Manager Julie Jordan and Vice President, Sales and Marketing, Larry Cancro, remain in full force at all times; and
- 4) Service stops at the seventh inning, or an appropriate time determined by the Management of Harry M. Stevens in the event of a delayed game.

By letter dated November 18, 2013, the Licensee requested a hearing to reconsider the conditions of the license. The Commission held a hearing on Tuesday, January 14, 2014, where the Licensee argued that good cause exists to reconsider the terms of the license.

The requested amendments to the conditions are:

- Condition no. 2: the License is to be used for Major League Baseball games or other private or public events at Fenway Park when Yawkey Way is closed for such events;
- > Condition no.4: Alcoholic Beverages sales cease at the end of the seventh inning or earlier at the Management's discretion.

Based on the evidence, the Commission allows the motion to reconsider the conditions on the License and imposes the following:

- 1) Alcohol sales are not to begin until 2 hours prior to the start of a game;
- 2) The License is to be used for Major League Baseball games or other private or public events at Fenway Park when Yawkey Way is closed for such events;
- All additional staffing and security personnel and measures stipulated to in the letter dated August 22, 2002, to this Commission from General Manager Julie Jordan and Vice President, Sales and Marketing, Larry Cancro, remain in full force at all times; and
- 4) Alcoholic Beverages sales cease at the end of the seventh inning or earlier at the Management's discretion.
