





# Overview

## Beyond Mobility Highlights


- Three-year contract to address deficiencies across the tunnel network to maintain **Safety** and **Reliability**.
- Work performed under this contract consistent with findings of MHS Triennial Inspection
- The MHS tunnels are integral to **Destination Connectivity** within the greater Boston region including transportation to/from Logan Airport.



# Project Scope

Comprehensive scope of tunnel system preservation with major activities including:

- Repairs to Callahan Tunnel ceiling and ventilation systems
- Repairs to tunnel ventilation buildings
- Repairs to tunnel fire standpipe
- Repairs to tunnel slurry walls
- Repair or replacement of ceiling girder-bay hatches
- Repair/replacement of tunnel wall panels
- Removal and replacement of existing drainage, electrical, and access structures frames and covers in roadway.
- Cleaning of tunnel drainage system



# Construction Management Approach

- Design-Bid-Build Project
- Construction Managed by MassDOT Highway District 6
- Three (3) year construction duration
- Notice to proceed anticipated by December 2025

Contract work will be managed as follows

- Travel lane closures shall be restricted along I-93 mainline to Sunday through Thursday from 11:30 p.m. to 5:00 a.m.
- Contractor to notify District 6 Operations one week prior to proposed temporary roadway closures for coordination with MassDOT Maintenance activities and local cultural and sporting events.



# Procurement and Budget

- Project Advertised June 07, 2025
- Engineer’s estimate was \$41,871,668.00
- Bid opening held August 19, 2025
- Two (2) bids were received:
