



Overview

Beyond Mobility Highlights

4

- Primary goal is to provide a raised cement concrete median on Route 6 (Scenic Highway) to physically separate the eastbound and westbound directions of travel increasing **safety**.
- Shared use path is proposed on canal side of roadway improving mobility and **travel experience** for bicyclists and pedestrians.
- Geometric improvements are needed to address roadway cross slope and vertical sight distance supporting **safety** and **travel experience**.
- Existing stormwater infrastructure needs to be upgraded supporting **resiliency**.



Scope of Services

5



Pavement Work:

- Combination of pavement milling with overlay and full depth pavement reconstruction for approximately 1.5 miles of Route 6 (Scenic Highway) from Nightingale Pond Road to Edgehill Road in Bourne.

Additional Work:

- **Stormwater Management:** Stormwater control measures and new closed drainage system
- **Upgrade Safety Hardware:** Installing MASH-compliant highway guard
- **Traffic Control Management:** Installing new traffic and pedestrian signals, pavement markings and signage
- **Retaining Walls**
- **Vegetation Management**
- No bridge work is included in this project.

Construction Management Approach

6

- The proposed schedule includes one 8-hour shift per day, 5 days a week, between the hours of 7:00 am and 3:30 pm.
- Night work will be allowed for Stage 1 work between 8:00pm and 6:00am, Sunday through Thursday nights to accommodate a westbound lane closure.
- Construction will take approximately five construction seasons to complete.
