### **DECISION**

RYMCO INC. D/B/A LIBERTY WAREHOUSE LIQUORS 21 ST. MARGARET STREET BOURNE, MA 02532

LICENSE#: 00046-PK-0118 VIOLATION DATE: 5/25/2022

**HEARD:** 8/09/2022

Rymco Inc. d/b/a Liberty Warehouse Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, August 9, 2022, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Velez's Report.

#### FINDINGS OF FACT

- 1. On Wednesday, May 25, 2022, at approximately 4:20 p.m., Investigators Binienda and Velez ("Investigators") inspected the business operation of Rymco Inc. d/b/a Liberty Warehouse Liquors.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, a 6-pack of Black Cherry White Claw Hard Seltzer for eleven dollars and twenty-nine cents (\$11.29). The underage operative was not asked for identification.

3. Dena Rymsha, Licensee, appeared at the Commission hearing along with the employee who sold the alcoholic beverages to the underage operative, and Susan Guest, Manager. Ms. Rymsha testified as to steps taken after the Compliance Check to prevent future violations. She stated she has posted many signs, retrained employees about properly requesting and examining identification and requires all patrons produce identification.

#### CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING.**
