Three Star News Inc d/b/a Braintree Highland Market ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, July 29, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Gardner and Smiddy's Minimum Purchase Age Compliance Check Field Report.

- 2. ABCC Form 43, New License Approval, 12/02/2010;
- 3. Licensee Stipulation of Facts.

## **FINDINGS OF FACT**

- 1. On Wednesday, May 14, 2025, at approximately 6:38p.m., Investigators Gardner and Smiddy ("Investigators") conducted a compliance check at Three Star News Inc d/b/a Braintree Highland Market.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 16 ounce Bud Light beer for two dollars (\$2.00). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2010.

### CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
