**AMENDMENT TO THE TOWN OF BREWSTER
RENEWAL CABLE TELEVISION LICENSE**

WHEREAS, the Town of Brewster, a municipal corporation with a principal place of business at 2198 Main Street, Brewster, MA, acting by and through its Select Board granted a Renewal Cable Television License (“License”) to Comcast Cable Communications Management, LLC (“Comcast”), dated June 21, 2021; and

WHEREAS, the term of the License runs from September 18, 2021 to September 17, 2031; and

WHEREAS, the Town and the Licensee desire to change the terms of Section 7.1 pertaining to an inadvertent reference to continuation of a full-time customer service office; and

WHEREAS, the Town and the Licensee have complied with the procedural requirements for amending the License as set out in Code of Massachusetts Regulations title 207, Section 3.07 and in accordance with the referenced regulations allowed for a public comment period which commenced on November 29, 2021;

NOW THEREFORE, the parties agree to amend the License as follows:

1. By deleting the existing Section 7.1 in its entirety, and substituting in place therefore the following new section 7.1:

Licensee shall comply with all customer service regulations of the FCC (47 CFR §76.309), and the regulations of the Massachusetts Department of Telecommunications and Energy, Cable Division, governing billing practices, at 207 CMR §10.01, et. seq., as they exist or as they may be amended from time to time. Likewise, Licensee shall comply with the customer service regulations promulgated by the Cable Division as they exist or as they may be amended from time to time.

2. All other terms and conditions of the LICENSE shall remain the same.
