FINAL DECISION

On September 6, 2018, the Petitioner Brian D. Stonkus, Trustee of Stonkus Family

Nominee Trust ("the Petitioner") filed this appeal challenging a Unilateral Administrative Order

("UAO") that the Central Regional Office of the Massachusetts Department of Environmental

Protection ("MassDEP" or "the Department") issued to the Petitioner on August 16, 2018 for

purported violations of the Massachusetts Wetlands Protection Act ("MWPA"), G.L. c. 131,

§ 40, and the Department's Wetlands Regulations at 310 CMR 10.00. The Department issued

the UAO in connection with certain activities that occurred at the Petitioner's real property at 19

Balm of Life Spring Road in Uxbridge, Massachusetts ("the Site").

Currently pending before me for review pursuant to 310 CMR 1.01(8)(c), is a proposed Settlement Agreement that the Petitioner and the Department have executed to settle the Petitioner's appeal of the UAO. The Settlement Agreement is in the form of a Settlement

Agreement By Administrative Consent Order and Notice of Non-Compliance ("Consent Order")

that was executed by: (1) the Petitioner on March 11, 2019 and (2) Mary Jude Pigsley, Regional

Director of the Department's Central Regional Office, on April 3, 2019.

After reviewing the Consent Order, I find that it is reasonable and furthers the statutory

and regulatory interests of the MWPA and the Wetlands Regulations. Accordingly, I issue this

Final Decision approving and incorporating the Consent Order. Pursuant to the Consent Order,

I issue the following Orders:

(1) In accordance with the second paragraph numbered 22, at p. 6 of the Consent

Order, the effective date of the Consent Order is the date of this Final Decision.

(2) The Petitioner shall perform all of the actions set forth in ¶ 8A-8D of the

Consent Order within the deadlines established by those provisions of the Consent Order.

(3) In accordance with ¶¶ 6 and 12 of the Consent Order, G.L. c. 30A, and 310 CMR

1.01(8)(c), this appeal is dismissed with the parties waiving whatever rights they may have to

further administrative review before the Department as well as any appeal to Court.
