### Goals of the Worcester Recovery Center and Hospital

DMH inpatient facilities promote recovery and resiliency and are integral to the continuum of care for all consumers across Massachusetts. They are vital to achieving the DMH mission and our commitment to Community First — promoting recovery for consumers and a life of independence and selfdetermination in communities of their choice.

### **Benefits of the New Hospital**

The 320-bed recovery center and hospital will serve 260 adults and 60 adolescents from across the Commonwealth.

### State-of-the-art facility fulfills three key priorities for DMH continuing care services

- Provides a high-quality, safe and respectful treatment setting while promoting active rehabilitation.
- Promotes recovery and return to community living as soon as possible.
- Promotes operational efficiencies and cost effectiveness.

#### **Components of Clinical Care**

- Multidisciplinary treatment teams including psychiatry, psychology, social work and occupational therapy with nursing care.
- Medication administration and medication education.
- Opportunities for therapeutic interventions including individual therapy, group therapy related to illness management and family outreach counseling.
- Focus on health and wellness.

#### **Care and Choices for Patients**

- WRCH incorporates elements of light and movement, inviting consumers to move from their unit into "neighborhoods" of shared clinical activity space to community areas that feature a bank, gym and other aspects of community living, fostering recovery and community reintegration.
- Multi-disciplinary treatment teams develop individualized treatment plans which may include individual and group therapy, rehabilitative services, and psychopharmacology.
- These features are recognized by architectural and accrediting agencies as essential for promoting dignity, choice, and respect for people with mental illness.

## Hospital Design: A Facility Within a Community

Design of WRCH is revolutionary, as it emulates within the hospital the natural structure of home, neighborhood, and community.

WRCH is state-of-the-art because of its therapeutic approach of promoting patients' ability to move from small to larger group interactions.

WRCH design is flexible and can accommodate future advances in clinical care and adapt to address the ever-changing nature and needs of adults, youth and families.

# The Making of a New DMH Hospital for Massachusetts

**February 2004**: DMH Inpatient Study Report to the General Court recommended the consolidation of Worcester State Hospital and Westborough State Hospital and construction of a new facility.

**2005**: The Division of Capital Asset Management (DCAM) and DMH partnered in a study with Ellenzweig Associates, Inc. and a diverse group of stakeholders to determine the optimal design for a new hospital.

**2005**: The Legislature convened the "DMH Facility Feasibility Commission", which was comprised of legislators, consumers and family members.

**2006**: The Feasibility Commission recommended that a DMH hospital be sited on the existing Worcester State Hospital campus.

**Spring 2007**: The Legislature and Administration accepted the Commission's recommendations and a Bonding Bill was passed.



DCAM Designer Selection Board selected architects Ellenzweig Associates, Inc. and Architecture+, a firm known for designing psychiatric facilities.

**Spring 2009**: The Groundbreaking and construction started.



August 2012: The Worcester Recovery Center and Hospital (WRCH) Opens.
