DECISION

**HANUMAN CORP. D/B/A ROSES DISCOUNT LIQUORS
186 OAK STREET, UNIT 2A
BROCKTON, MA 02301

Hanuman Corp. d/b/a Roses Discount Liquors (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, September 19, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Lordan's Report.

The following documents are in evidence:

1. Investigator Lordan's Compliance Check Field Report; and
2. Licensee's Stipulation of Facts.

A. TIPS Certificate for A. Patel.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

1. On Monday, June 12, 2017, at approximately 7:25 p.m., Investigators Carey and Lordan ("Investigators") investigated the business operation of Hanuman Corp. d/b/a Roses Discount Liquors.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 24-ounce bottle of Coors Light beer, for two dollars and fifty cents (\$ 2.50). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has had no prior violations, the Commission issues a **WARNING**.


