**DECISION**

Mayuri Sahil Corp. d/b/a Debi's Convenience & Deli ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, March 10, 2026, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Temple & Smith's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Temple & Smith's Minimum Purchase Age Compliance Check Field Report, 6/25/2025;
2. ABCC Form 43, Transfer of License Approval, 8/10/2016;
3. Licensee Stipulation of Facts.

There is one (1) audio recording of this hearing.

**FINDINGS OF FACT**

1. On Wednesday, June 25, 2025, at approximately 6:16 p.m., Investigators Temple & Smith ("Investigators") conducted a compliance check at Mayuri Sahil Corp. d/b/a Debi's Convenience & Deli.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 25-ounce container of Bud Light beer, for three dollars and fifty-five cents (\$3.55). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2016.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
