#### **DECISION**

LIQUOR EXPRESS LLC D/B/A COOLIDGE CORNER WINE 1300 BEACON STREET **BROOKLINE, MA 02446** LICENSE#: 88907-PK-0148 **VIOLATION DATE: 5/23/2023** 

HEARD: 11/14/2023

Liquor Express LLC d/b/a Coolidge Corner Wine ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, November 14, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Watson and Teehan's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Watson and Teehan's Minimum Purchase Age Compliance Check Field Report, 5/23/2023;
- 2. Licensee's Stipulation of Facts;
- 3. ABCC Accela Summary, Transfer of License Approved, 11/23/2016.

### FINDINGS OF FACT

- 1. On Tuesday, May 23, 2023, at approximately 6:48 p.m., Investigators Watson and Teehan ("Investigators") conducted a compliance check at Liquor Express LLC d/b/a Coolidge Corner Wine.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one Corona beer, for three dollars and fifty cents (\$3.50). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2016.

#### CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
