Amsoni Inc. d/b/a Shelburne Falls Neighbors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, October 1, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Kenny & Temple's Minimum Purchase Age Compliance Check Report.

The following documents are in evidence:

1. Investigators Kenny & Temple's Minimum Purchase Age Compliance Check Field Report, 6/20/2024;
2. ABCC Form 43, New License Approval, 2/19/2004;
3. ABCC Decision, 12/16/2016;
4. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

1. On Saturday, June 20, 2024, at approximately 6:09 p.m., Investigators Temple and Kenny ("Investigators") conducted a compliance check at Amsoni Inc. d/b/a Shelburne Falls Neighbors.
2. An underage operative, working under the supervision of Investigators, was sold alcoholic beverage, one 24-ounce Bud Light beer for three dollars and ninety-nine cents (\$3.99). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2004.

CONCLUSION


Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission **issues a WARNING.**
