### 9. Additional Business / Other matters as not reasonably anticipated 48 hours in advance of meeting

a. For Informational purposes:

There are currently:

- o 738 certified building inspectors -- 297 Local 441 Inspector of Buildings
- o 49 Conditional local building inspectors
- 588 individuals' qualifications have been approved to take the exams, not currently affiliated
- b. Copy of letter from Paul Moriarty with Code Change Proposal to add *Business and Temporary appointments and other proposed changes* was received and reviewed. Charles Kilb stated the Attorney General's office would not render a formal interpretation, as requested by Paul Moriarty, only heads of agencies would render an interpretation. And, the BBRS has authority to render interpretations to their own laws and regulations. Furthermore, all code change proposals submitted by Felix Zemel are illegal and cannot be adopted.
- c. Charles Kilb indicated the BBRS formally acknowledged the Building Official Certification Committee should work on code change proposals of R7 Certification of Inspectors of Buildings, Building Commissioners and Local Inspectors for the 10<sup>th</sup> edition of the Building Code. This will be on BOCC's March agenda.
- d. There was a continuing discussion regarding the appropriate signature on the New Employee Report Forms. Charles Kilb stated he has a lengthy memo with an interpretation as to who is considered the *Appointing Authority*.
