#### 6. Extension Requests to be Certified Packets

R7.1.7.4-5 a conditional appointee may petition the Building Official Certification Committee (BOCC) using the Extension Request form for an extension of time to comply with the examination schedule of R7. Upon establishment of cause, the BOCC may grant such an extension of time as it may consider appropriate.

- a) On a MOTION by John Naff and seconded by Jeff Clemons it was VOTED to grant the request of **Michael Ciampa (Town of Arlington)** for a first extension of time to become certified as a building commissioner. Said extension shall expire July 31, 2023. Bill Horrocks and Michael Clancy opposed.
- b) On a MOTION by Andy Bobola and seconded by John Naff it was unanimously VOTED to grant the request of **Daniel Shipp (City of Beverly)** for a second extension of time to become certified as a local inspector. Said extension shall expire July 31, 2023.
- c) On a MOTION by John Naff and seconded by Michael Clancy it was unanimously VOTED to grant the request of **John Walsh**, **Jr. (Town of Wilbraham)** for a second extension of time to become certified as a local inspector. Said extension shall expire July 31, 2023.

#### 7. Hearings

- a) The hearing for Ronald Laurin, BOCC 01-2023, Town of Southampton, was cancelled Since Mr. Laurin passed the required exams to be certified as a Massachusetts Building Commissioner.
- b) On a MOTION by Michael Clancy and seconded by Dave Fuller it was unanimously VOTED to deny James Perry (Town of Halifax) BOCC 02-2023 for an extension of time to become certified as a local inspector. After testimony by James Perry the Committee determined Mr. Perry did not put forth enough effort to complete the required exams to be certified as a local inspector. He stated performing his extra duties with the town has prevented him from taking the final exam to be certified as a local inspector.
  - Mr. Perry provided proof of passing the B1, Residential Building Inspector exam December 14, 2016 and the B2, Commercial Building Inspector exam January 28, 2017. He failed the F3 December 22, 2022 and is scheduled to retake the exam January 26, 2022.
