4. Examination Approval Packets

The Committee was unable to find sufficient supervisory experience in building construction or design in Slater Panosian's résumé to determine if they have the minimum qualifications as defined by MGL c 143 § 3.
- b. On a MOTION by Dave Fuller and seconded by John Naff it was VOTED to grant the request of **Dean Bliss** (No Affiliation) for approval to take the required exams to become certified as a building code enforcement official. Dean Bliss meets the minimum qualifications set forth by the BBRS for said position of local inspector and inspector of buildings / building commissioner defined by MGL c 143 § 3 and was granted permission to proceed with the required examination process. Bill Horrocks opposed.
- c. On a MOTION by Jeff Clemons and seconded by Dave Fuller it was VOTED to DENY the request of Kyle Tucker (Town of Hudson) for approval to take the required exams to become certified as a building code enforcement official. The Committee was unable to find sufficient supervisory experience in building construction or design in Kyle Tucker's résumé to determine if they have the minimum qualifications as defined by MGL c 143 § 3. John Naff and Bill Horrocks opposed.
- d. On a MOTION by John Naff and seconded by Dave Fuller it was unanimously VOTED to DENY the request of **Benjamin Lebowitz** (No Affiliation) for approval to take the required exams to become certified as a building code enforcement official. The Committee was unable to find sufficient supervisory experience in building construction or design in Benjamin Lebowitz's résumé to determine if they have the minimum qualifications as defined by MGL c 143 § 3.
- e. On a MOTION by John Naff and seconded by Jeff Clemons it was unanimously VOTED to grant the request of **Daniel Otto** (No Affiliation), based on education, for approval to take the required exams to become certified as a building code enforcement official. Daniel Otto meets the minimum qualifications set forth by the BBRS for said position of local inspector and inspector of buildings / building commissioner defined by MGL c 143 § 3 and was granted permission to proceed with the required examination process.

- f. On a MOTION by Dave Fuller and seconded by Henry Fontaine it was unanimously VOTED to grant the request of **Alberto Medina-Florez** (No Affiliation), pending receipt of proof of his degree, for approval to take the required exams to become certified as a building code enforcement official. Once proof of his architectural degree is received Alberto Medina-Florez will meet the minimum qualifications, based on education, set forth by the BBRS for said position of local inspector and inspector of buildings / building commissioner defined by MGL c 143 § 3 and will be granted permission to proceed with the required examination process.
- g. On a MOTION by John Naff and seconded by Henry Fontaine it was unanimously VOTED to DENY the request of **Michelle Haska** (No Affiliation) for approval to take the required exams to become certified as a building code enforcement official. The Committee was unable to find sufficient supervisory experience in building construction or design in Michelle Haska's résumé to determine if they have the minimum qualifications as defined by MGL c 143 § 3.
- h. On a MOTION by John Naff and seconded by Michael Clancy it was unanimously VOTED to grant the request of **Gregory Monka** (No Affiliation) for approval to take the required exams to become certified as a building code enforcement official. Gregory Monka meets the minimum qualifications set forth by the BBRS for said position of local inspector and inspector of buildings / building commissioner defined by MGL c 143 § 3 and was granted permission to proceed with the required examination process.
