STATE BOARD OF BUILDING REGULATIONS AND STANDARDS BUILDING OFFICIAL CERTIFICATION COMMITTEE

Vice Chair Jeffrey Clemons called the meeting to order at 8:59 am and called roll:

- 1. Members present reviewed the minutes from the last meeting on March 7, 2023; MOTION to approve these minutes was made by David Fuller, seconded by Henry Fontaine.
- 2. On MOTION by Andrew Bobola seconded by Michael Giampietro, it was unanimously VOTED that Jeffrey Clemons will now serve as Chair of the Committee. This follows the resignation of Chair Bill Horrocks. The Committee Members thanked Bill Horrocks for his service.

3. Application for Certification Packets

a. On a MOTION by Michael Clancy and seconded by David Fuller it was unanimously VOTED to approve the application of **Richard Pereira** (BO-2313, Town of Barnstable) for certification in the capacity of **Local Inspector**, having met the minimum qualifications of the position as defined by MGL c. 143 § 3.

b. On a MOTION by Michael Clancy and seconded by Andrew Bobola it was unanimously VOTED to approve the application of **Timothy Travers** (BO-2333, no affiliation) for certification in the capacity of **Inspector of Buildings / Building Commissioner**, having met the minimum qualifications of the position as defined by MGL c. 143 § 3.

4. Examination Approval Packets

- a. On a MOTION by Michael Clancy seconded by Dave Fuller it was unanimously VOTED to DENY the request of **Mark Augello** (no affiliation) for approval to take the required exams to become certified as a building code enforcement official. The Committee was unable to find sufficient supervisory experience in building construction or design in Mark Augello's résumé to determine if they have the minimum qualifications as defined by MGL c. 143 § 3.
- b. On a MOTION by Michael Giampietro seconded by Henry Fontaine it was unanimously VOTED to grant the request of **Daniel Correia** (no affiliation) for approval to take the required exams to become certified as a building code enforcement official. The applicant meets the minimum qualifications set by the BBRS for said position of local inspector of buildings / building commissioner as defined by MGL c. 143 § 3 and was granted permission to proceed with the required examination process.
- c. On a MOTION by John Naff seconded by Michael Giampietro it was unanimously VOTED to DENY the request of **Peter D'Agostino** (no affiliation) for approval to take the required exams to become certified as a building code enforcement official. The Committee was unable to find sufficient supervisory experience in building construction or design in the applicant's résumé to determine that they have the minimum qualifications as defined by MGL c. 143 § 3.
- d. On a MOTION by David Fuller seconded by John Naff it was unanimously VOTED to DENY the request of **Dolores Dibrinisi** (no affiliation) for approval to take the required exams to become certified as a building code enforcement official. The Committee was unable to find sufficient supervisory experience in building construction or design in the applicant's résumé to determine that they have the minimum qualifications as defined by MGL c. 143 § 3.
- e. On a MOTION by David Fuller seconded by Michael Clancy it was unanimously VOTED to grant the request of **Sangmok Kim** (no affiliation) for approval to take the required exams to become certified as a building code enforcement official. The applicant meets the minimum qualifications set by the BBRS for said position of local inspector of buildings / building commissioner as defined by MGL c. 143 § 3 and was granted permission to proceed with the required examination process.
- f. On a MOTION by John Naff seconded by Henry Fontaine it was unanimously VOTED to DENY the request of **Joseph Lynskey** (no affiliation) for approval to take the required exams to become certified as a building code enforcement official. The Committee was unable to find sufficient supervisory experience in building construction or design in the applicant's résumé to determine that they have the minimum qualifications as defined by MGL c. 143 § 3.
- g. On a MOTION by John Naff seconded by Michael Clancy it was unanimously VOTED to DENY the request of **Theodore Pontz** (no affiliation) for approval to take the required exams to become certified as a building code enforcement official. The Committee was unable to find sufficient supervisory experience in building construction or design in the applicant's résumé to determine that they have the minimum qualifications as defined by MGL c. 143 § 3.

- h. On a MOTION by David Fuller seconded by John Naff it was unanimously VOTED to grant the request of **Gregory Salamida** (no affiliation) for approval to take the required exams to become certified as a building code enforcement official. The applicant meets the minimum qualifications set by the BBRS for said position of local inspector of buildings / building commissioner as defined by MGL c. 143 § 3 and was granted permission to proceed with the required examination process.
- i. On a MOTION by David Fuller seconded by John Naff it was unanimously VOTED to DENY the request of **Dave Scott** (no affiliation) for approval to take the required exams to become certified as a building code enforcement official. The Committee was unable to find sufficient supervisory experience in building construction or design in the applicant's résumé to determine that they have the minimum qualifications as defined by MGL c. 143 § 3.
- j. On a MOTION by John Naff seconded by Henry Fontaine it was unanimously VOTED to DENY the request of **Michael J. Wallace** (no affiliation) for approval to take the required exams to become certified as a building code enforcement official. The Committee was unable to find sufficient supervisory experience in building construction or design in the applicant's résumé to determine that they have the minimum qualifications as defined by MGL c. 143 § 3.

5. New Employee Reports

- a. On a MOTION by Jeffrey Nash seconded by David Fuller it was VOTED to acknowledge the New Employee Report Form of **Carl Bizarro** appointed to the position of Building Commissioner for the Town of Freetown on January 1, 2023. Andrew Bobola abstained. *NERF signed by Chair*.
- b. On a MOTION by Michael Giampietro seconded by Jeffrey Nash it was unanimously VOTED to acknowledge the New Employee Report Form of **Joseph Fitzpatrick** appointed to the position of Local Inspector for the Town of Uxbridge on August 8, 2022.
- c. On a MOTION by David Fuller seconded by Michael Clancy it was unanimously VOTED to acknowledge the New Employee Report Form of **Gregory Salamida** appointed to the position of Local Inspector for the Town of Salem on March 13, 2023.
- d. On a MOTION by Andrew Bobola seconded by John Naff it was unanimously VOTED to acknowledge the New Employee Report Form of **George Shaw** appointed to the position of Local Inspector for the City of Holyoke on March 20, 2023.
- e. On a MOTION by John Naff seconded by Henry Fontaine it was unanimously VOTED to acknowledge the New Employee Report Form of **Joseph Tierney**, **Jr.** appointed to the position of Building Commissioner for the Town of Chilmark on February 21, 2023.
- f. On a MOTION by John Naff seconded by David Fuller it was unanimously VOTED to DENY acknowledge the New Employee Report Form of **Michael J. Wallace** appointed to the position of Local Inspector for the Town of Ayer on November 15, 2022. The Board has DENIED Michael J. Wallace authorization to take the relevant certifying examination based on lack of required experience. It was also noted that Town did not provide the NERF for Mr. Wallace until 7 months after Mr. Wallace was appointed to the position, a violation of 780 CMR 110.R7.1.7.4. On these facts, the Town is prohibited under MGL c. 143 § 3 and 780 CMR 110.R7.4.1.7 from allowing Mr. Wallace to act in the capacity of Local Inspector.

6. Extension Requests

R7.1.7.4-5 a conditional appointee may petition the Building Official Certification Committee (BOCC) using the Extension Request form for an extension of time to comply with the examination schedule of R7. Upon establishment of cause, the BOCC may grant such an extension of time as it may consider appropriate.

- a) On a MOTION by Michael Clancy and seconded by Andrew Bobola it was unanimously VOTED to grant the request of **Jeffrey Gougeon** (Franklin County Cooperative Inspection Program (FCCIP) / Franklin Regional Council of Governments (FRCOG)) for a first extension of time (6 months) to become certified as a Local Inspector. Said extension shall expire November 2, 2023.
- b) On a MOTION by David Fuller and seconded by Andrew Bobola it was unanimously VOTED to grant the request of **Edward Murray** (Town of Brookline) for a first extension of time (6 months) to become certified as a Local Inspector. Said extension shall expire November 2, 2023.
- c) On a MOTION by Michael Giampietro and seconded by John Naff it was unanimously VOTED to grant the request of **Terrance Quinn** (Town of Falmouth) for a second extension of time (6 months) to become certified as a Local Inspector. Said extension shall expire November 2, 2023.

7. Hearings

a. BOCC 05-2023 **Slater Panosian** (Town of Belmont) appealed the Committee's 2/7/2023 vote to deny his qualifications for appointment based on lack of construction supervision experience. On MOTION by John Naff and seconded by David Fuller it was unanimously voted to DENY his appeal. Members also took action to make a public records request of the Town of Halifax to determine his activities during his time with the Town.
