This agency does not contract with ICC or Prometric for the required exams to be certified as a local inspector. The BBRS only utilizes the exam results for certification.

- not to accept any exams using 2018 reference codes
- only accept exams using the current I Codes for the current Massachusetts Building Code.
- Accept exams to be used on the next Building Code to be adopted
 - Prometric is only offering the NCPCCI exams using 2018 I Codes
 - ICC is offering equivalent exams using 2012, 2015 or 2018 I Codes
 - Exams are to familiarize the inspectors on how to look up information; if 2018 reference codes are used for the exams the inspector will utilize this information in the field during inspections or during the permitting process
 - Building inspectors should only be tested on the building code currently being used. Educate the inspectors on what is being used in the field to alleviate mistakes
 - Inspectors will purchase reference materials (2018 I codes) that will never be used in Massachusetts
 - \$1179.00 to purchase 2018 ref material for all three required exams
 - \$209 per exam
 - Contractors are being tested on the 9th Edition of the Building Code referencing 2015 I codes
