(U//LES) TEMA reports an active shooter incident at 1015AM at United States Marine Corps Reserve Center at 4051 Amnicola Highway in Chattanooga, TN. Two Marines are wounded (status unknown) and one law enforcement officer was also wounded in the leg (non-life threatening). One shooter is "down". Responding law enforcement officials are on the scene and investigating whether there was more one shooter. Additional reporting is that there have been shootings at multiple locations (NFI).




