

**FINAL DECISION**

I have reviewed the attached Administrative Consent Order with Penalty and Notice of Noncompliance signed on October 22, 2020 by Harry Jacobvitz, President of Bush & Co., Inc., and by Millie Garcia-Serrano, Regional Director for the Department (Enforcement No. 00009227).

The Department issues this Final Decision incorporating the Administrative Consent Order with Penalty. The Petitioner is ordered to pay a civil administrative penalty of sixty thousand dollars (\$60,000) with a suspended amount of (\$50,000) contingent upon the petitioner's compliance with the terms of the settlement agreement and in accordance with paragraphs 12 and 24 of the Administrative Consent Order with Penalty. Under the terms of 310 CMR 1.01(8)(c), these proceedings are dismissed with the parties waiving whatever rights they may have to further administrative review before the Department as well as any appeal to court.
