Be Prepared for When Disaster Strikes

September marks a time when daylight hours wane and the inevitability of fall and winter becomes increasingly apparent. In Massachusetts, this period is acknowledged as a time of planning and readiness: Governor Charlie Baker recently reaffirmed September as the Commonwealth's [Emergency Preparedness Month](#) to ensure the state stands at the ready as we face the possibility of hurricanes, winter storms, and other ever-present emergency situations. Hurricane Florence and the Merrimack Valley gas line incident underscore why we should take notice.



Statewide Contract Resources

Part of the Operational Services Division's responsibility to address the Commonwealth's goods and services requirements is ensuring [Statewide Contracts](#) afford quick access to resources during times of emergency. To meet this need, several hundred Statewide Contract Vendors are designated as emergency suppliers based on their ability to expedite orders to meet the urgent needs of agencies, municipalities, and schools. OSD publishes a list of [Emergency Response Supplies, Services, and Equipment Contact Information](#) to help buyers identify and connect with our emergency suppliers. Relay questions regarding OSD's Statewide Contracts to the OSD Contract Manager listed on the [Contract User Guides](#) or the [Statewide Contract Index](#).

Understanding what's available and how to get resources quickly is crucial during an emergency. "The vendors on our emergency response listing have committed to special accommodations, such as fulfilling product and service needs on a 24/7 basis or enabling buyers to pick up essential items outside of normal business hours," states Maureen Barends, Director of Strategic Sourcing for OSD. "This is a resource you'll want to have at your fingertips," she continued.

Be proactive. When a disaster strikes, Internet access may be difficult. OSD recommends printing and laminating copies of this [listing](#) for use in emergency response centers and emergency response vehicles. Take time now to download the information to your smartphone, tablet, or other battery powered device for easy access during an emergency situation. Also download the [Massachusetts Alerts](#) app, developed by the Massachusetts Emergency Management Agency (MEMA), to your smartphone or tablet to receive emergency alerts, along with public safety incident and disaster information.

MEMA Stands Ready to Assist

OSD works closely with MEMA throughout the year and especially during emergencies. "From truckloads of drinking water to batteries for flashlights, MEMA relies on Statewide Contracts for every emergency situation," said David Mahr, MEMA Chief Administrative Officer.

For example, on the Fourth of July, MEMA worked with a Statewide Contract Vendor to obtain three pallets of water bottles – which were delivered within 24 hours and on the holiday – to help provide relief to the public safety staff (police, fire, National Guard) working the holiday celebration on the Esplanade as temperatures hovered at the 90° mark. "Statewide vendors are our partners before, during, and after incidents," said Tina Urato, MEMA Business Management Specialist. "They go above and beyond every time!"

COMMBUYS Reverse Auction Garner Big Savings

Over the summer, the Operational Services Division hosted its first, in-house reverse auction in [COMMBUYS](#). The four-day competition for the state's road salt business, involving nine pre-qualified vendors, resulted in significant price reductions that will be passed along to Commonwealth buyers over the 2018-2019 winter months. Moreover, by using COMMBUYS, the state was able to save even more by eliminating the expense associated with engaging an outside entity to run the auction.

The COMMBUYS reverse auction tool was well suited for the VEH107 Road Salt bid, which sought the lowest possible price for the supply and delivery of regular and pre-treated road salt across 18 MassDOT regions – a limited number of items, with significant dollars in play. “This was a high-stakes auction,” asserts Steve Lyons, OSD Contract Manager for Road Salt. “Massachusetts is one of the largest road salt customers in the country. The reverse auction required bidders to aggressively compete for our business. It was a huge success, especially for our first time hosting an auction in COMMBUYS.”

The auction, initially scheduled for two days, was extended to four as vendors continued to submit lower and lower bids through COMMBUYS, lengthening the bidding period on each occasion and maximizing the opportunity for greater savings.

Ensuring a Smooth Path

In the weeks leading up to the reverse auction, Steve Lyons and the COMMBUYS Operations Team worked diligently to ensure the auction would go off without a hitch. While the Operations Team tweaked and tested the COMMBUYS reverse auction tool, Steve spent a good deal of time working with the vendors to prepare them for the COMMBUYS auction. The participating vendors were required to attend a three-hour, in-person, OSD training session and they received an instruction booklet outlining their roles and responsibilities. Steve notes that, “Preparation was key. All the bidders worked directly with OSD to learn how to compete in the reverse auction. The COMMBUYS Operations Team played an essential, hands-on role from start to finish.”

Road Salt Prices *Decreasing 18% for FY2019!*

Buyers using the Road Salt Statewide Contract this coming winter season will realize substantial savings, a direct result of OSD's recent reverse auction (see story titled "COMMBUYS Reverse Auction Returns Significant Savings for the Commonwealth" on page 2). Hosted for the first time in COMMBUYS, the Commonwealth's online procurement platform, the auction generated lively competition for the state's business from nine pre-qualified vendors.



Save \$8-\$12 per Ton over Last Year's Price

In the end, all MassDOT areas will see substantial price reductions for both Regular and Pre-Treated Road Salt through the new VEH107 contract and the Commonwealth as a whole will reap sizable savings – VEH107 Road Salt will be offered at *more than 18% below last year's pricing*.

In particular, we encourage representation from schools, hospitals, Sheriffs' Departments, and Executive Agencies with large grocery requirements, i.e. Department of Correction, Department of Youth Services, and the Soldiers' Homes in Chelsea and Holyoke. Participants will help structure the bid and be part of the bid evaluation and contract award. Travel into Boston is not required.

Buyers Experienced with COMMBUYS – Advanced Purchasing in COMMBUYS

Targeting our more experienced COMMBUYS users, the class covers the following transactions:

- Solicitation Enabled Release – For Statewide Contracts designated as solicitation enabled, obtaining quotes from Statewide Contract vendors through COMMBUYS;
- Request for Payment Authorization (RPA) Release Requisitions – Appropriately documenting Statewide Contract purchase orders in COMMBUYS after purchases are made;
- RPA Requisitions – Documenting non-Statewide Contract purchases in COMMBUYS after-the-fact when the normal procurement process is impractical or due to an impending need.

Note: *COMMBUYS Purchasing* is a prerequisite.

Buyers Involved in Procurement – Strategic Sourcing Certificate Program

This course, which meets once a week for five weeks, outlines industry best practices and provides the skills to conduct successful procurements. The course includes classroom instruction, guest speakers, small group exercises, and time for participants to share experiences and deliberate outcomes.

Best Value Procurement Handbook Update:

Revised Instructions for Statewide Contract Procurement Exceptions

The [Best Value Procurement Handbook](#) outlines policy requirements and best practices in accordance with procurement regulation, 801 CMR 21.00.



Effective immediately, OSD has issued revised instructions for Departments requesting authorization to issue a bid for goods or services covered by Statewide Contract. When Departments provide their detailed explanation of why the Statewide Contract does not meet their needs, they now must include a screenshot of the Summary tab of the bid in COMMBUYS, as well as copies of all attachments, if a request for quote was issued and no acceptable responses were received. This new guidance is reflected in the Handbook (VII. Appendices, Section A).

Note: In many cases, Statewide Contract Vendors can be responsive to buyers' needs by adding products that fall within the scope of the contract. If a product or service you seek is not currently available but appears to fall within the contract's parameters, reach out to the OSD Contract Manager to discuss.

New Product to Secure Classroom Doors

Due to high demand, TeacherLock, a new, locally developed product designed to secure a classroom door in the case of an intruder, has been added to Statewide Contract [FAC64](#), Security, Surveillance, Monitoring and Access. Similar safety- and security-related products of many types, and installation, also are available on FAC64. While OSD does not recommend any products or services over others, in the interest of public safety and clarity, and also because of the demand for this product, we are referencing it by name. If current contractors become familiar with similar public safety technologies, they should bring them to the attention of [Ashish Patel](#), OSD's Contract Manager, who also is available to respond to contract questions.

OSD's Vehicle Auctions Continue In-Person and Online

It was a busy summer for OSD's State Surplus Property Office. Over the course of three months, the office hosted four vehicle auctions at various locations in Massachusetts. These events attracted hundreds of registered bidders, including car dealers, auto parts and repair professionals, and members of the general public. The inventory also was diverse, offering a selection of sedans, SUVs, trucks, hybrid vehicles, and others. About 100 vehicles were sold at each auction with an average sale price of \$1,027 per vehicle. The Surplus Property office will host another [vehicle auction](#) on September 28 in Ayer, Massachusetts, followed by their final auction of the year in November.

If you are unable to attend a live auction, surplus property from OSD also is available throughout the year via online auctions hosted by [Auctions International](#). Every posted auction item includes a comprehensive description and is accompanied by a series of photos. Prospective buyers who are uncomfortable making a purchase sight unseen have the option to request a third-party inspection. Once the sale is finalized, it is the buyer's responsibility to retrieve the item, regardless of its location.

A recent online auction offered a number of used transportation vans, but online auctions aren't limited to vehicles. Medical, computer, and office equipment are auctioned online throughout the year.
