ADDENDUM A DIRECTIONS TO NEW DIA FALL RIVER OFFICE 1 FATHER DEVALLES BOULEVARD, FALL RIVER

On April 1, 2008 the DIA's Fall River Office will be relocated to One Father DeValles Boulevard, Fall River. All proceedings scheduled on or after April 1st will take place at the new location. Directions to the new Fall River Office are as follows:

From North of Fall River take Route 24 South to I-195 West. From I-195 West take Exit 8A – Rt. 24 South. Then take Exit 2 – Eastern Ave./Brayton Ave. Turn right at end of ramp onto Brayton Ave. Follow Brayton Ave. to the second set of traffic lights (there will be a strip mall with a Dunkin' Donuts and Subway shop on the left side of Brayton Ave.). Turn Left onto Father DeValles Blvd. and follow to the end. Father DeValles Blvd. ends in the parking lot of the two building complex. The DIA's office is on the third floor of the West building (the 4-floor structure – look for DIA sign at the entrance).

From South of Fall River take Route 24 North to Exit 2 – Eastern Ave./Brayton Ave. Turn right at end of ramp onto Brayton Ave. Follow Brayton Ave. to the first set of traffic lights (there will be a strip mall with a Dunkin' Donuts and Subway shop on the left side of Brayton Ave.). Turn Left onto Father DeValles Blvd. and follow to the end. Father DeValles Blvd. ends in the parking lot of the two building complex. The DIA's office is on the third floor of the West building (the 4-floor structure – look for DIA sign at the entrance).

From East of Fall River take I-195 West to Exit 8A – Rt. 24 South.
