By decision dated September 6, 2012, CDM International Enterprises, LLC dba Kitchen Sushi & Lounge was found in violation of 204 CMR 2.01 (8). The Commission ordered the license be indefinitely suspended effective September 6, 2012 until further written order of the Commission.

On November 27, 2012, the Commission issued a Memorandum and Order on the Licensee's Petition to Vacate Order of Indefinite Suspension.

The Commission hereby **suspends the licensee's license for a total of ninety (90) days**. The licensee has already served a suspension of its license for eighty-three (83) days in the aggregate pursuant to the prior order of indefinite suspension. **The balance of the suspension to be served is seven (7) days.**

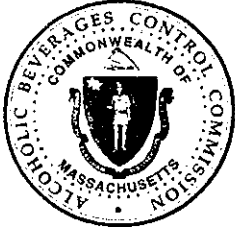
**The suspension shall commence on Wednesday, November 28, 2012 and terminate on Thursday, December 4, 2012.** The license will be delivered to the Local Licensing Board or its designee on Wednesday, November 28, 2012 at 9:00 A.M. It will be returned to the licensee Wednesday December 5, 2012.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.

MEMORANDUM AND ORDER ON  
LICENSEE'S PETITION TO VACATE ORDER OF INDEFINITE SUSPENSION

CDM International Enterprises, LLC dba Kitchen Sushi & Lounge (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday August 8, 2012 regarding an alleged violation of 204 CMR 2.01 (8). By decision dated September 6, 2012, the Commission **INDEFINITELY SUSPENDED FORTHWITH** the license until further written order of the Commission.


On October 31, 2012, the Licensee through counsel filed a Petition to Vacate Order of Indefinite Suspension. The Commission held a hearing on Tuesday, November 20, 2012, regarding the Licensee's Petition to Vacate Order of Indefinite Suspension of the Commission's decision of indefinite suspension issued on September 6, 2012. The licensee attended a hearing before the Commission and argued that good cause exists to reconsider the indefinite suspension.

The licensee filed an application to change the License Manager from Derek Brady to another individual. That application was granted by the local board and forwarded to the Commission for its approval. The Commission approved this Change of Manager application on November 27, 2012.

Based on the evidence, the Commission reconsiders and reverses its prior order of INDEFINITE SUSPENSION of CDM International Enterprises, LLC dba Kitchen Sushi & Lounge license **effective forthwith**. **The indefinite suspension is reconsidered and reversed to a suspension of ninety (90) days. No fine in lieu of suspension will be accepted. The license has been suspended since September 6, 2012 and thus has already served eighty-three (83) days. The license will be returned to the licensee on Wednesday December 5, 2012.**


