New Cobb Corner Liquor Inc. d/b/a Canton Village Wine & Spirits ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, September 10, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Cutter and Teehan's Minimum Purchase Age Compliance Check Field Report.

- 2. ABCC Form 43 License, Transfer of License Approval, 9/17/2015;

FINDINGS OF FACT

- 1. On Monday, June 10, 2024, at approximately 4:57 p.m., Investigators Cutter and Teehan ("Investigators"), conducted a compliance check at New Cobb Corner Liquor Inc. d/b/a Canton Village Wine & Spirits.
- 2. An underage operative working under the supervision of Investigators purchased an alcoholic beverage, one 16-ounce can of Bud Light beer, for four dollars and nineteen cents (\$4.19). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2015.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
