Area Need Improvement	The Human Rights Committee did not include a valid voting member with clinical expertise for eight out of eight meetings. The agency needs to recruit a clinician to be a voting member of their Human Rights Committee to ensure that the required expertise is present at meetings.
Status at follow-up	The agency's Human Rights Committee had met on one occasion during the follow-up review period. The Human Rights Committee met membership, attendance, and quorum requirements for this meeting. A review of the Human Rights Committee meeting minutes verified that the committee fulfilled its role and responsibility in reviewing incidents, investigations, restraints, and other areas as required.
