**DECISION**

**SOUTH CARVER LIQUOR CORP. D/B/A CARVER SQUARE WINE & SPIRITS**  
**123 MAIN STREET**

South Carver Liquor Corp. d/b/a Carver Square Wine & Spirits ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, October 11, 2022, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Kenny's Report.

The following documents are in evidence:

1. Investigator Kenny's Minimum Purchase Age Compliance Check Field Report, 6/15/2022;
2. ABCC Licensing Authority Certification, Transfer License approved, 11/01/2019;
3. Licensee's Stipulation of Facts.

**FINDINGS OF FACT**


1. On Wednesday, June 15, 2022, at approximately 5:56 p.m., Investigators Cutter and Kenny ("Investigators"), inspected the business operation of South Carver Liquor Corp. d/b/a Carver Square Wine & Spirits.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 6-pack of Bud Light beer, for nine dollars (\$9.00). The underage operative was not asked for identification.

### CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.




