CLEAN ENERGY TRANSMISSION WORKING GROUP

In July 2022, the Massachusetts State Legislature passed An Act Driving Clean Energy and Offshore Wind, St. 2002, c. 179 ("Act"), which requires the Department of Public Utilities ("Department") to convene a stakeholder working group to provide a comprehensive cost analysis of major transmission infrastructure upgrades that may be needed to deliver clean energy generation procured pursuant to the laws of the Commonwealth for the use of residents of the Commonwealth and the region, and develop and approve a final report, along with any recommendations for legislative and regulatory actions at the state, regional, and federal level. The Act designated a seventeen-member working group. As a multi-member committee established to serve a public purpose, the members are subject to open meeting law.

The Department will conduct the next working group meeting virtually using Zoom videoconferencing on **Thursday, December 21, 2023** beginning at **8:00 a.m.** Attendees can join the hearing by entering the link, https://us06web.zoom.us/j/89464312200, from a computer, smartphone, or tablet.
