**Public Meeting Minutes**

**AUGUST 5, 2021**

A public meeting of the Massachusetts Board of Registration of Chiropractors (the Board) was held remotely by videoconference as an alternate means of public access pursuant to Massachusetts General Law enacted on June 16, 2021 suspending certain provisions of the Open Meeting Law.

Dr. Dodes noted a quorum of members present and called the meeting to order at 10:03 a.m.

**CHAIRMAN'S MESSAGE**

Dr. Dodes said the COVID-19 pandemic remains upon us and we must remain vigilant to prevent its spread.

## **LEGAL REPORT**

- **COVID-19 State of Emergency Update**

Atty. Kilb said the primary COVID-19 State of Emergency ended on June 14, 2021.

He said a face covering requirement for certain healthcare settings, including chiropractic offices, was simultaneously issued on 6/14/21 via a separate, more limited state of emergency declaration.

- **DPL Article 87**

Atty. Kilb said the Governor's reorganization legislation that includes moving the Board of Chiropractors from the DPL to the DPH was enacted. He said there is an 18-month window for the change to complete.
