PUBLIC MEETING MINUTES

FEBRUARY 4, 2021

A posted public meeting of the Massachusetts Board of Registration of Chiropractors (the Board) was held remotely by telephone or by videoconference as an alternate means of public access pursuant to an Executive Order issued by the Governor of Massachusetts dated March 12, 2020, suspending certain provisions of the open meeting law.

Dr. Shilts noted a quorum of members present and called the meeting to order at 10:00 a.m.

CHAIRMAN'S MESSAGE

Dr. Shilts informed the Board about a Texas Supreme Court decision that came down on 1/29/21. He said the case is a chiropractic scope of practice matter involving the Texas Medical Association (plaintiffs) and the Texas Chiropractic Board of Examiners (defendants).

He said the court determined that the Texas Chiropractic Board has jurisdiction to codify chiropractic scope in their state where they are the statutory authority on the practice of chiropractic. The court rejected the Texas Medical Assoc. argument that every procedure performed by a chiropractor must be contained in statute.

Dr. Shilts said this has a parallel to the dry needle myotherapy issue that we're presently discussing in Massachusetts.
