1. Legislative Authority

Section 2 of Chapter 258F of the General Laws requires certifying entities to adopt a policy for completing and signing nonimmigrant status certification forms for: (i) victims of criminal activity who intend to petition for nonimmigrant visas under 8 U.S.C. 1101(a)(15)(U); and (ii) victims of severe forms of trafficking in persons who intend to petition for nonimmigrant visas under 8 U.S.C. 1101(a)(15)(T).

Section 1 of the same chapter defines a certifying entity as “a law enforcement agency, prosecutor or other state or local entity that has the authority to detect, investigate or prosecute severe forms of trafficking in persons or criminal activity.”

Section 3 establishes a timeline for the certifying entity’s response to the victim and Section 4(a) requires that each certifying entity report to the Executive Office of Public Safety and Security (EOPSS): (i) the number of individuals that requested nonimmigrant status certification; (ii) the number of certification forms that were completed and signed; and (iii) the number of such requests that were denied.

Subsection (b) of Section 4 creates the authority for this report:

Annually, not later than April 1, the Executive Office of Public Safety and Security shall file a report with the clerks of the house of representatives and the senate, the joint committee on the judiciary and the joint committee on public safety and homeland security on the information received under subsection (a). The report shall include, but not be limited to:

- (i) the number of individuals that requested nonimmigrant status certification, delineated by certifying entity;
- (ii) the number of certification forms that were completed and signed, delineated by certifying entity;
- (iii) the number of such requests that were denied, delineated by certifying entity; and
- (iv) total statewide statistics on nonimmigrant status certifications and denials. The report shall not include information that would allow the public to ascertain the identity of an individual requesting nonimmigrant status certification. The executive office shall also make the report publicly available on its website.

2. Data Gathering

In compliance with M.G.L. c. 258F, § 4(b), EOPSS compiled the data submitted by the certifying entities pursuant to § 4(a). To streamline the data-gathering process, EOPSS issued an electronic survey to certifying entities¹ requesting aggregate numbers for the required data points. The survey was sent to:

- Massachusetts State Police;
- Massachusetts Chiefs of Police Association;
- Massachusetts District Attorneys Association;
- Massachusetts Sheriffs’ Association;
- Department of Correction;

- Executive Office of Health and Human Services²;
- Attorney General’s Office;
- Massachusetts Department of Children and Families;
- Massachusetts Commission Against Discrimination;
- Massachusetts Division of Industrial Accidents³;
- Massachusetts Trial Court⁴;
- Massachusetts Department of Criminal Justice Information Services;
- Massachusetts Department of Mental Health⁵; and
- Massachusetts Office of Elder Affairs.⁶

3. Calendar Year 2024 Data

The reporting requirements of M.G.L. c. 258F, § 4(b) took effect at the beginning of the fiscal year 2022. Below sets forth the required data received by EOPSS delineated by certifying entities for the calendar year 2024 (January 1, 2024 - December 31, 2024).

Please note that the certification process for a request may span more than one calendar year. This may be due to the date the request was received or other circumstances related to the request that require additional time. As such, requests may be at various stages of the process at the end of the calendar year and, therefore, may not be reflected in the certifications completed or denied for that year. The data is reported as it was submitted.

The total statewide statistics on data received by EOPSS on nonimmigrant status certifications and denials from January 1, 2024, to December 31, 2024, are illustrated below. Out of the 605 requests for nonimmigrant status certification, 427 forms were completed and signed, and 145 requests were denied.



4. Steering Committee

Section 133 of Chapter 24 of the Acts of 2021 created an interagency crime victim certification steering committee and gave EOPSS the authority to convene the committee. Currently, the committee is meeting bi-monthly to fulfill its requirements. The steering committee's activities include:

- (i) developing training materials for employees of certifying entities and other individuals who may interact with victims of criminal activity or victims of severe forms of trafficking in persons, including, but not limited to, victim advocates, court personnel, or state agency personnel;
- (ii) creating sample policies to be utilized by certifying entities; providing technical assistance to certifying entities; and

- (iii) monitoring the implementation of the policies required under chapter 258F.

As required by Section 133 the steering committee shall file a report with the clerks of the senate and house of representatives, the joint committee on the judiciary, and the joint committee on public safety and homeland security by December 31, 2023. The report will include:

- (i) a description of the activities of the steering committee;
- (ii) an overview of issues implementing the requirements of said chapter 258F;
- (iii) any recommendations to improve compliance with said chapter 258F; and
- (iv) any other information the steering committee deems relevant.

The report will also be made available on the EOPSS website.

5. Conclusion

EOPSS looks forward to continuing to collaborate with its many committed stakeholders, including the steering committee, to fulfill the requirements of M.G.L. chapter 258F and Section 133 of Chapter 24 of the Acts of 2021.
