7.1.2. Transport

Tandem Switched Transport

Tandem-Switched Transport consists of the circuits used in common by multiple customers from the LEC's access tandem to the Telephone Company's end office. The Tandem-Switched Transport Rate includes four sub-elements: a Tandem-Switched Transport – Termination rate, a Tandem-Switched Transport rate, a Tandem Switch Rate and a Shared Multiplexing rate. The third sub-element, Tandem Switch Rate does not apply for Telephone Company's current Network Configuration. The other sub-elements are provide below:

1. The Tandem-Switched Transport – Termination element is a usage rated, per minute. Rate to recover costs incurred at the ends of the transmissions links.
2. The Tandem-Switched Transport element is usage rated and distance-sensitive, i.e., a per access minute per airline mile rate. The rate recovers costs of the transmission facilities, including intermediate transmission circuit equipment, between the end-points of the circuits.
