**DECISION**

**SCLX INC. D/B/A SOUTH CHATHAM LIQUORS

SCLX Inc. d/b/a South Chatham Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, September 3, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Velez & Binienda's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Velez & Binienda's Minimum Purchase Age Compliance Check Field Report, 6/10/2024;
2. ABCC Licensing Authority Certification, Transfer of License Approved 5/31/2023;
3. Licensee's Stipulation of Facts.

**FINDINGS OF FACT**


1. On Monday, June 10, 2024, at approximately 5:25 p.m., Investigators Velez & Binienda ("Investigators"), conducted a compliance check at SCLX Inc. d/b/a South Chatham Liquors.
2. An underage operative working under the supervision of Investigators purchased an alcoholic beverage, one White Claw Mango Hard Seltzer, for two dollars and ninety-nine cents (\$2.99). The underage operative was not asked for identification.
3. The Licensee has held this license under M.G.L. c. 138, § 15 since 2023 with no previous violations.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
