DECISION

TAKE TWO ONE TEN GRILL LLC D/B/A 110 GRILL 116 CHELMSFORD STREET CHELMSFORD, MA 01824

LICENSE#: 00081-RS-0200 VIOLATION DATE: 5/24/2023

Take Two One Ten Grill LLC d/b/a 110 Grill ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, October 24, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Velez and Binienda's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Velez and Binienda's Minimum Purchase Age Compliance Check Field Report, 5/24/2023;
- 2. ABCC Form 43, New License Approval, 11/19/2013;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Wednesday, May 24, 2023, at approximately 4:15 p.m., Investigators Binienda and Velez ("Investigators") conducted a compliance check at Take Two One Ten Grill LLC d/b/a 110 Grill.
- 2. An underage operative, working under the supervision of Investigators, was served an alcoholic beverage, one 16-ounce Coors Light draft beer. The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2013 with no prior violations.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
