DECISION

**THE YU RESTAURANT GROUP CORPORATION D/B/A NOBO RESTAURANT
20 BOSTON ROAD
CHELMSFORD, MA 01824
LICENSE#: 020000083
VIOLATION DATE: 04/24/2017
HEARING DATE: 07/11/2017**

The Yu Restaurant Group Corporation d/b/a Nobo Restaurant (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, July 11, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Doyle's Report.

The following documents are in evidence:

1. Licensee's Stipulation of Facts; and
2. Investigator Doyle's Compliance Check Field Report.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS


1. On Monday, April 24, 2017, at approximately 6:15 p.m., Investigators Bailey and Doyle ("Investigators") investigated the business operation of The Yu Restaurant Group Corporation d/b/a Nobo Restaurant.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a Budweiser Light beer, for four dollars and twenty-five cents (\$4.25). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission **suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**
