



Water-Smart Program for Lead in Drinking Water at Schools and Early Education and Childcare Facilities

UMass Amherst

Chelsea Seminar Report October 2024

Summary of the Event

The Massachusetts Department of Environmental Protection- Drinking Water Program's (MassDEP-DWP) — Water Smart* Program hosted a seminar in conjunction with the city of Chelsea and the Massachusetts Department of Public Health (DPH) to raise awareness about lead exposure. It was held on September 24th from 6-8 PM at the Williams Jr. High School and a total of 54 participants attended, including childcare providers, education professionals, Chelsea officials, nonprofit organizations, DPH staff, and MassDEP staff.

The program covered a range of topics, including lead exposure in drinking water, the free lead testing <u>Water-Smart Program</u>, the <u>Childhood Lead Poisoning Prevention Program</u>, the <u>Choose Safe Places for Early Care and Education Program</u>, the <u>Service Line Inventory</u>, and the <u>Lead Service Replacement Program in Chelsea</u> (Figure 2 and 3).

Deneen Simpson, MassDEP Director of Environmental Justice, successfully secured the necessary funding to provide meals for attendees (Figure 5). In addition to the training materials, each participant received a certificate of attendance from MassDEP-DWP, which can be applied towards the Department of Early Education and Care (DEEC) annual training requirement for childcare providers (Figure 6).

Our Collaborators




Figure 9. Claudia Vega and Ana Rodriguez, childcare owners, sharing their experiences participating in the Water-Smart Program.

The City of Chelsea was identified as a High-Risk Community in the 2022 Annual Childhood Lead Poisoning Surveillance Report as well is categorized as a disadvantaged community (Tier 3) with an Environmental Justice (EJ) population. In an effort to protect children's health, Flor M. Amaya Lopez, Chelsea's Director of Public Health assembled a diverse group of collaborators (Figure 7) to assist the community. This coalition includes representatives from nonprofit organizations such as Early Childhood Initiative, GreenRoots, Clean Water Action as well as key players in childcare systems: Tania Perez and Mayra Rosado from Nurtury, Darling Ortiz and Rosalina Pinto from Clarendon and Claudia Vega from Child Development and Education. Chelsea resident Fran Roznowski is also contributing to this collaborative effort. Together, this group is dedicated to reaching out to and educating the community about the childrens health (Figure 7 and 9). After the seminar, a children's book was distributed to raise awareness about lead exposure in the environment (Figure 8).

Water-Smart Program and Future Work in Chelsea

Since 1988, the <u>Massachusetts Department of Environmental Protection</u> (MassDEP) <u>Drinking Water Program</u> (DWP) has taken a proactive stance in addressing and eliminating lead in school drinking water. The Water-Smart Program is a voluntary program for public and private schools and licensed early education and care facilities that offers technical assistance with lead in drinking water outreach and education, water testing, and support for remediation actions. Upon completion of the program, facilities are provided with a certificate of completion to display.

Following this seminar, the Water-Smart Program will continue collaborating with Chelsea partners to encourage all childcare facilities in the city to participate in lead testing. The goal is to ensure that any facilities with lead concentrations above the laboratory analytical testing limit of 1 part per billion (ppb or µg/L) take the necessary remediation actions based on program recommendations. So far, 30% (11) of the Family-Based Child Care centers in Chelsea have agreed to participate in the program, and 19% have already completed the testing. Additionally, to engage and educate parents and the Chelsea community, Clean Water Action, in collaboration with the City of Chelsea, will host a free information session on October 23 from 6:00 to 8:00 PM at the Chelsea Public Library (Figure 11). The session will focus on lead in drinking water, including ways residents can assist the Chelsea Water & Sewer Department in completing their lead service inventories. Participants will also learn about the benefits their childcare facilities can gain by joining the Water-Smart Program.
