Alcoa Catering Service Inc. d/b/a Cavalier Steakhouse (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, August 20, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Temple's Report.

FACTS

- 1. On Wednesday, April 17, 2019, at approximately 4:55 p.m., Investigators Watson and Temple ("Investigators") investigated the business of Alcoa Catering Service Inc. d/b/a Cavalier Steakhouse.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a Bud Light beer. The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 more than 10 years with no prior violations.
