**JAI SHREE RAM CORP. D/B/A PLAZA LIQUORS

Jai Shree Ram Corp. d/b/a Plaza Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, August 27, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Kujawski & Gould's Minimum Purchase Age Compliance Check Field Report.

FINDINGS OF FACT

1. On Wednesday, April 17, 2024, at approximately 6:26 p.m., Investigators Kujawski and Gould ("Investigators"), conducted a compliance check at Jai Shree Ram Corp. d/b/a Plaza Liquors.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 24-ounce Peach Twisted Tea for three dollars and fifty cents (\$3.50). The underage operative was not asked for identification.


3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2006.

CONCLUSION


Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.


