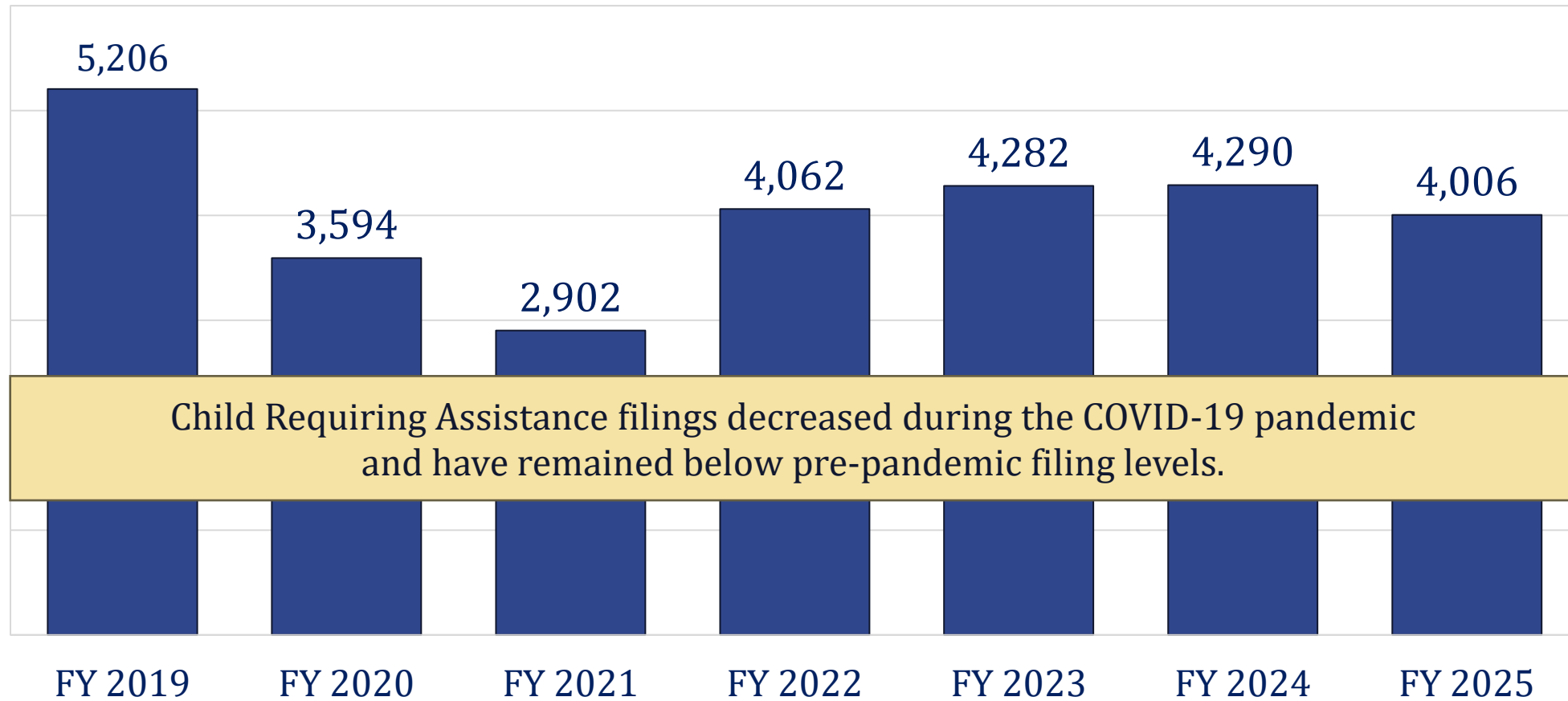
Background



- The purpose of this review is to provide information for the most recent fiscal years on schools and/or school districts that file CRA Truant and Habitual School Offender actions in the Juvenile Court.
- Child Requiring Assistance (CRA) petitions can be filed in the Juvenile Court for a child between the ages of 6 and 18.
- There are five types of CRA actions: an application for a child who repeatedly runs away from home (runaway), an application for a child who does not follow the parent, legal guardian, or custodian's rules (stubborn), an application for a child who is sexually exploited (sexually exploited), an application for a child who is habitually absent and does not attend school (truant), and an application for a child who is a habitual school offender who does not obey the school's rules (habitual).
- A CRA application for runaway or stubborn may be filed by a parent, legal guardian, or legal custodian. A CRA application for truant or habitual school offender may be filed by a school and/or school district. A CRA application for a sexually exploited child may be filed by a parent or police officer.

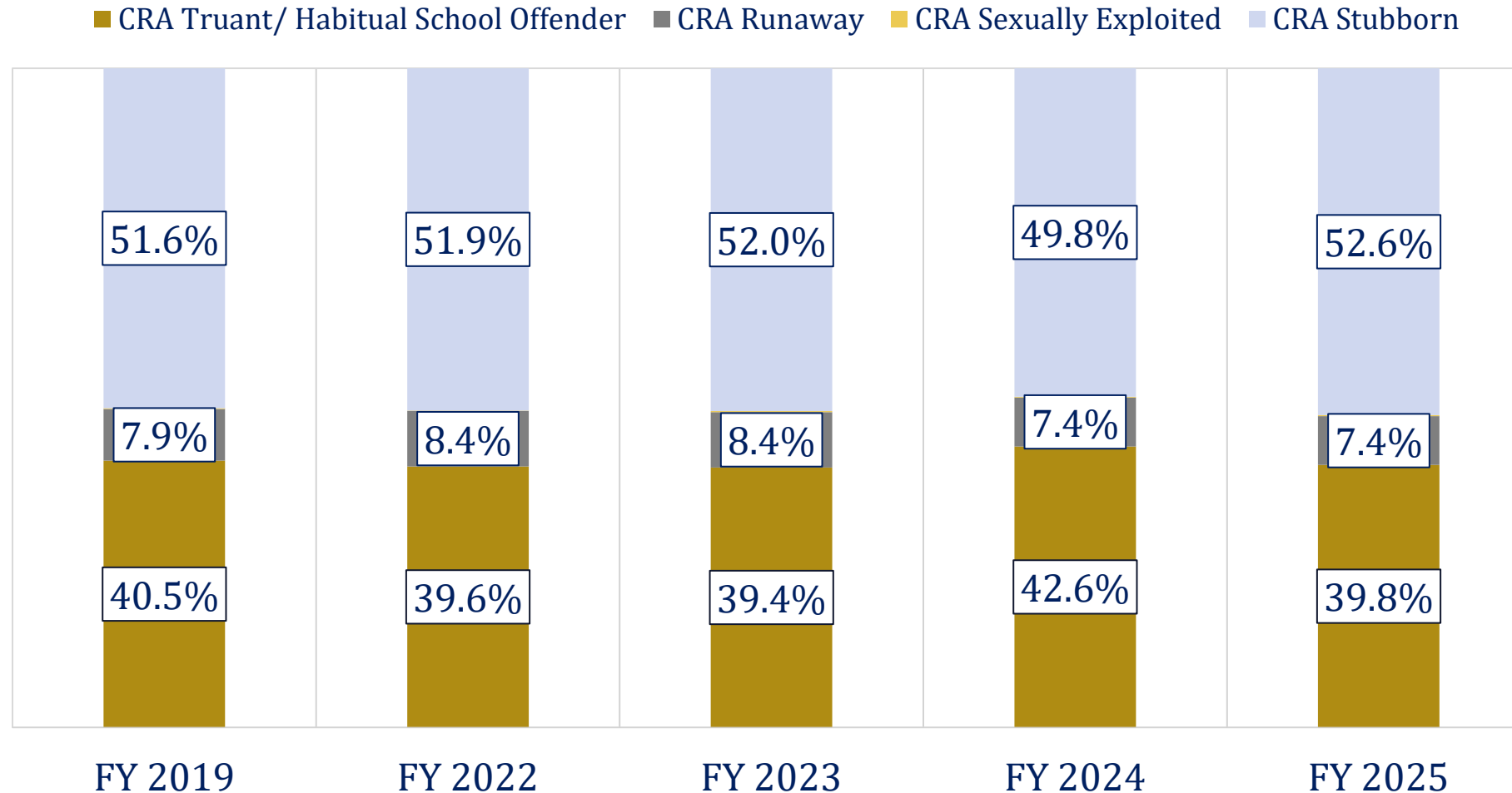


Child Requiring Assistance Cases Filed, Last Seven Fiscal Years

Child Requiring Assistance (CRA) Filings in FY 2019 and FY 2025: CRA Truant/Habitual School Offender by Court Division

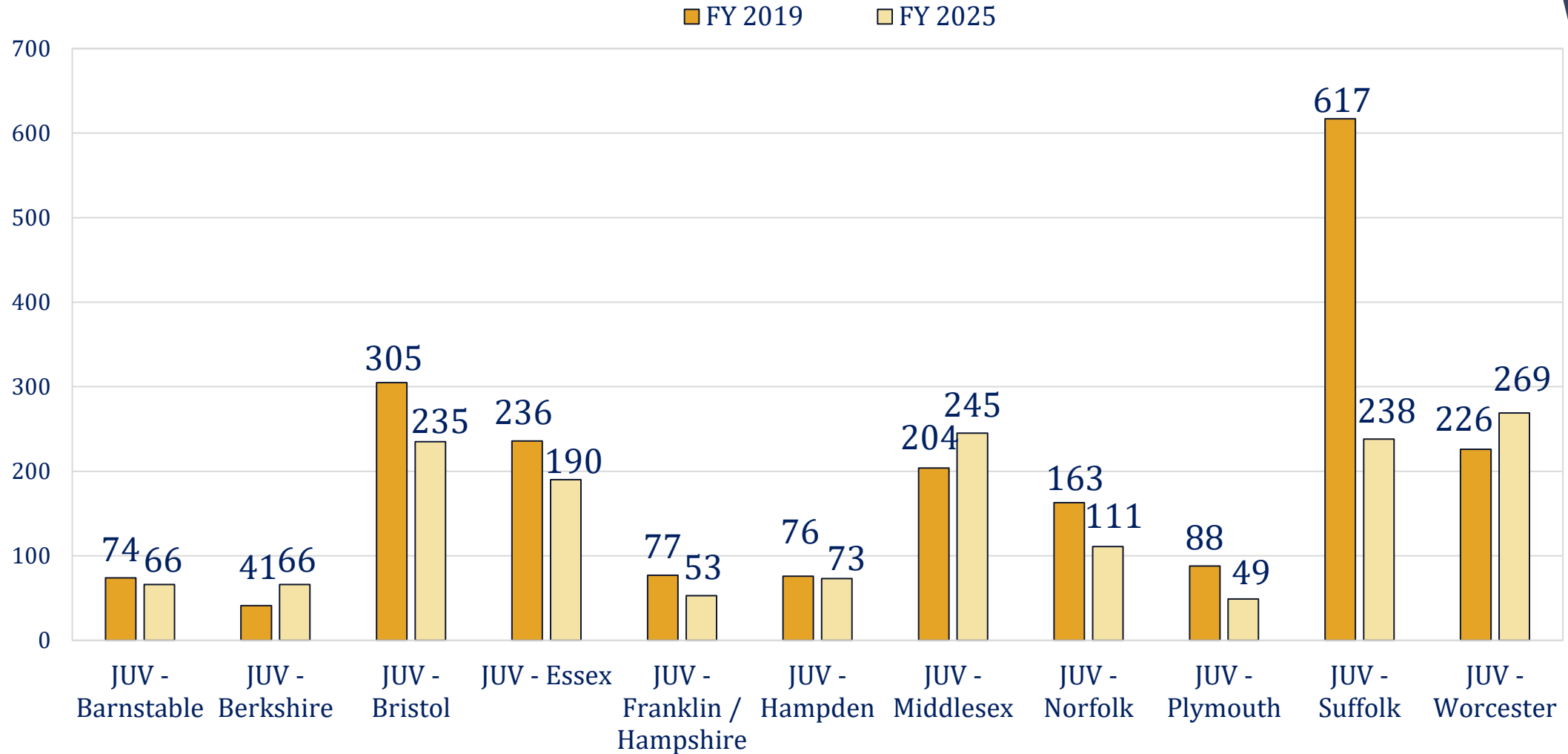
