### **NOVEMBER 9, 2017**

Dr. Shilts noted a quorum of members present, and the meeting was called to order at 10:12 a.m.

### **CHAIRMAN'S MESSAGE:**

Dr. Shilts took a moment to thank Dr. Maddalo for serving as Secretary last month in Dr. Storozuk's absence. He also spoke about observing the NBCE Part IV examination in St. Louis and how Dr. Imonti served as a test examiner in Port Orange, Florida. He encouraged other board members to get involved with the NBCE as an examiner or test preparation participant.

# **LEGAL REPORT:**

Thereafter, a Motion was made by Dr. Imonti, seconded by Dr. Dodes, and VOTED (unanimous); to accept the submitted 72 hours of CE credits and allow Dr. Flores to move forward with reinstatement of her Massachusetts license.

• Dr. Nathan Cintron:

• Reciprocity:

After a discussion, it was decided that the Board should review Chapter 112, Section 92 of Massachusetts General Law and the policy process for reciprocity, and continue handling reciprocity applications on a case-by-case basis.

# **RECIPROCITY APPLICATION:**

• Dr. John Vasko:

Atty. York discussed the application of Dr. Vasko for reciprocity. Dr. Vasko holds a current license in New Mexico with an issue date of 2001. The Board reviewed whether Dr. Vasko met the statutory and regulatory requirements for reciprocity in Massachusetts. The Board noted that in 2001 Massachusetts required parts III and IV of the national boards. After Board discussion, it was decided that Dr. Vasko was not eligible for licensure through his reciprocity application.

Thereafter, a Motion was made by Dr. Storozuk, seconded by Dr. Maddalo, and VOTED (unanimous); to deny reciprocity to Dr. John Vasko.
