Public Meeting Minutes

October 2, 2025

Dr. Grosso asked that the Executive Session be removed from the agenda as the applicant could not attend the meeting. Thereafter a motion was made by Dr. Debs, seconded by Dr. O'Malley and VOTED (roll call); to approve the October 2, 2025 agenda as amended.

PUBLIC MEETING MINUTES

Dr. Grosso asked for a motion to approve the draft September 4, 2025 meeting minutes. Thereafter a motion was made by Dr. Connors, seconded by Dr. Debs and VOTED (roll call); to approve the public meeting minutes of September 4, 2025 as drafted.

UPDATE ON BOARD MEMBERS

The Executive Director introduced and welcomed new board member, Dr. David Smith. She thanked Dr. Mary Connors for her service on the Board and noted that this was Dr. Connors' last meeting. The public member seat on the Board is vacant.

2026 BOARD MEETING DATES

The Board discussed the meeting dates for 2026. The January meeting needs to be rescheduled due to the New Year's Day holiday. The Board asked staff to confirm that the January meeting could be held on Wednesday, January 7, 2025, and report back at the November meeting.

BOARD COUNSEL UPDATE ON STAFFING

Sheila York, Esq., Board Counsel, informed the Board that two new board counsels joined the Bureau and introduced Emily Gauthier, Esq., who will be working with the Chiropractors Board.

OVERVIEW OF FCLB CHIROPRACTIC SPECIALTY PROGRAMS

Dr. Jon Schwartzbauer, Executive Director of the Federation of Chiropractic Licensing Boards, informed the Board about Recognized Chiropractic Specialty Programs (RCSP). RCSP is a service of the Federation of Chiropractic Licensing Boards (FCLB) which was started six years ago. RCSP establishes criteria and procedures for recognition of chiropractic specialty program providers. This helps doctors of chiropractic in choosing specialty programs and assists FCLB member boards in evaluating specialty providers and programs. Dr. Schwartzbauer noted that the goal was to have 17 jurisdictions signed on before launching to providers. Board Counsel, Sheila York, Esq., noted that the Board would most likely need statutory or regulatory changes to accept RCSP. The Board took this under advisement.

DISCUSSION

<u>Draft Policy - Criteria for Waiver of Chiropractor of Record Experience Requirement</u>

The Board discussed board member Kathleen O'Malley, D.C.'s draft petition for a waiver of the experience requirement for a chiropractor facility Chiropractor of Record (CHoR). The regulations require a CHoR to have a minimum of four years of verifiable experience as a licensed chiropractor, unless waived by the Board. Dr. O'Malley used the Board of Registration in Pharmacy's regulation regarding Petition for Waiver as a template. The draft guidance will set forth the factors the Board considers when reviewing a petition for waiver. The Board may waive

compliance with the experience requirement if it finds that it would serve public interest by granting the waiver to a licensed chiropractor, that the waived regulatory requirement would be impractical and unduly burdensome, and that there are sufficient safeguards to protect the public health, welfare, and safety without the petitioner's adherence to the waived minimum experience requirement. The Board's waiver form must be completed and signed by the proposed Chiropractor of Record for the chiropractic facility license and all other eligibility requirements for the chiropractic facility license must be met.

Dr. O'Malley's draft petition for the waiver serves as a framework for the policy. Board Counsel and the Executive Director will consider facility ownership and fine tune the criteria for a waiver in the draft policy. The Board gave direction to staff to update the draft policy for discussion at a future meeting.

Board adoption of Guidance for Chiropractic Practice in Massachusetts by Students Enrolled in their Final Year of Chiropractic College

The Board discussed the approved guidance. It was noted that a student extern may operate an x-ray only under the direct supervision of the preceptor chiropractor. Direct supervision requires the preceptor chiropractor to be on the same premises as the extern and readily available and able to offer assistance to the extern and patient, when the extern is providing patient care. Thereafter a motion was made by Dr. Debs, seconded by Dr. O'Malley and VOTED (roll call); to adopt the Guidance for Chiropractic Practice in Massachusetts by Students Enrolled in their Final Year of Chiropractic College.

REQUEST FOR CHANGE OF CHIROPRACTOR OF RECORD

Dr. Benjamin and Dr. Kathryn Murphy requested a Waiver of the Chiropractor of Record experience requirement to change the Chiropractor of Record for their facility, The Sanctuary Chiropractic Club, license CHF6718, to Dr. Kathryn Murphy. The Murphy's attended the meeting and answered questions from the Board. Mark Davini, D.C. serves as compliance officer for their facility. Thereafter a motion was made by Dr. Pulley, seconded by Dr. O'Malley and VOTED (roll call); to grant the waiver and accept the change in Chiropractor of Record for the facility.

REACTIVATION APPLICATION CHIRA100041

Dr. Siobhan McDonagh's license CHI3520 expired on March 31, 2020. Sixty (60) continuing education units were required for the license reactivation. In addition, Dr. McDonagh will need to retake and pass the jurisprudence exam because the license has been expired for over five years. The Board discussed the application. Thereafter a motion was made by Dr. Debs, seconded by Dr. O'Malley and VOTED (roll call); to approve the applicant to move forward in the licensing process.
