LEGAL REPORT

Atty. Kilb reported that the Board has new legal counsel, Atty. Sheila York.

EXECUTIVE DIRECTOR REPORT

Mr. Keigan reported that the Board has a new Executive Director, Lisa Guglietta, and a new Assistant Executive Director, Eboni Lewis.

DIVISION OF OCCUPATIONAL LICENSURE, DIVISION COUNSEL

Atty. Dick presented before the Board to answer questions about the Board's current status within the DOL and impending move over to the Department of Public Health (DPH).

• Applicant Background Checks

In response to a question, Atty. Dick said an audit of DOL's processes showed that all applicants for personal or facility chiropractic licensure have undergone both a CORI and SORI background check. He said a recent news article misconstrued a missing sign-off step as a non-performed background check, which is inaccurate.

• Health Care Fraud Unit Funding

In response to a question, Atty. Dick said he expects the Health Care Fraud Unit to follow the Boards of Chiropractors and Allied Health over to the DPH. He said he will relay the Board's concern that the Unit's dedicated funding to help combat health care fraud in the Automobile PIP insurance market remain as it was statutorily intended.

• Board Policy Guideline on Dry Needle Myotherapy

In response to a question, Atty. Dick did not know why the DOL does not have the Board's Policy Guideline on Dry Needle Myotherapy posted on its website. He said he will follow-up on the Board's concern that neglecting to post this important guideline may heighten the risk to consumers by hindering important information needed by our Commonwealth's practicing chiropractic physicians.
